Authorization to approve the conveyance of vacant lot Parcel 157 Front Avenue to Diane J.

Schultz.

Background

On June 9, 2016, Diane Schultz submitted an application to acquire the HRA owned Parcel 157

Front Avenue (property). The property is located adjacent to Diane's residence and acts as a

buffer between her residential property and the commercial property along Rice Street. In

accordance with the Disposition Policy, the application was posted for 45 day notification with

no response. The sale costs associated with the disposition will be paid by Seller. Buyer will be

required to combine the tax parcels for the property and 163 Front Avenue.

No Budget Action is being requested. The property will be conveyed by HRA to Diane for

\$1.00.

**Future Action** 

No future action is needed.

**Public Purpose** 

Conveyance of the Property will create a buffer between residential and commercial property,

block lights from the business and traffic bringing value and safety to the residential property.

Buyer will be required to combine the two parcels into one tax parcel.
