Thank you again for taking in to consideration my client's efforts to remedy the issues with this property. I have informed my client of the City's requirements that are to be met prior to our next hearing in this matter. Said follow-up hearing was tentatively scheduled for February 23, 2016.

As I was looking back at my file, I note that I incorrectly stated the date at which time the redemption period expires.
