**As owner or person(s) responsible for : 1270 CLEVELAND AVE S you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.**

1. Remove improperly stored or accumulated refuse including: garbage, rubbish, loose and scattered litter, discarded furniture, appliances, vehicle parts, scrap wood and metal, recycling materials, household items, building materials or rubble, tires, brush, etc., from yard areas, vacant land from Cleveland to Return Court, driveway, and property. INCLUDING ALL BUILDING MATERIALS, WOOD, TREE DEBRIS, CONSTRUCTION EQUIPMENT, CEMENT BLOCKS, GRANITE, FENCING, WINDOWS, AND DOORS. Thanks! Comply before November 30, 2016
2. Cut and remove any overgrown vegetation (including trees) impeding public right of way, sidewalk, boulevard, vacant land, and alley areas. Public sidewalks must be cleared edge-to-edge and up to seven (7) feet in height. Alleys and streets must be cleared from edge- to- edge and up to fourteen (14) feet in height, INCLUDING: PLEASE CUT BACK ALL OVERGROWN VEGETATION ALONG THE FENCE/PROPERTY LINES FROM CLEVELAND TO RETURN COURT. Thanks! Comply before November 30, 2016
3. Cut and remove tall grass, weeds and rank plant growth from yard, boulevard, vacant land, and alley areas, INCLUDING: PLEASE CUT ALL TALL GRASS/WEEDS/RANK PLANT GROWTH ON VACANT LOTS FROM CLEVELAND TO RETURN COURT. Thanks! Comply before November 30, 2016

If you do not correct the nuisance or file an appeal before November 30, 2016 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
