NOTICE OF PUBLIC HEARING

2017 Saint Paul Winter Carnival – Rice Park Sound Level Variance Request

Dear Saint Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Location: Rice Park

Noise Source: Saint Paul Festival and Heritage Foundation has requested a sound level variance to provide amplified sound for entertainment and talent performances on a stage in Rice Park for the 2017 Saint Paul Winter Carnival. The hours of operation for the stage will be:
