

The claims and causes of action ourrently pending before the Court in the above-entitled matter having been fully resolved to the satisfaction of the parties, it is hereby stipulated by and between the Parties hereto to grant Judgment in favor of Defendant ABC Supply Co., Inc. and dismiss all other causes of action, claims and defenses without prejudice and on the terms and conditions set forth below, but without further costs or disbursements to any of the parties.

It is hereby stipulated and agreed that without further notice, the Clerk of the above Court may enter judgment in favor of Defendant ABC Supply Co., Inc. It is further stipulated and agreed that as to all other remaining causes of action claims and defenses between Plaintiff Headset and Defendant Conrad, the parties agree to submit their dispute to binding arbitration per the terms and conditions of a executed "Agreement For Binding Arbitration" and to dismiss without prejudice their currently pending claims and defenses in the above entitled action.
