## Revocation of Fire Certificate of Occupancy and Order to Vacate

RE: 295 LARCH ST

Dear Property Representative:

Your building was inspected on September 13, 2016, for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code. A re-inspection will be made on or after October 13, 2016 or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

## **DEFICIENCY LIST**

- 1. **Exterior Storage** SPLC 62.101 Use of this property does not conform to zoning ordinance. Discontinue unapproved use or call DSI Zoning at (651) 266-8989 to convert to legal use. Discontinue: The use of the exterior for long-term storage of inoperable vehicles and auto parts is not approved under the current site plan (see attached). Contact DSI Zoning at (651)266-8989 to submit a modified site plan if the property is not to be used in accordance with the approved plan from 11-15-12. Per site plan approval letter, work was also not completed by the deadline of 11-15-13.
- 2. **Interior Tire Storage** MSFC 2302.1 Reduce and maintain storage height or provide approved high-piled storage protection. *Tire were stored to approximately 12-14 ft high.* Reduce the tire storage to a maximum of 12 ft high if stored on-tread or a maximum of 6 ft high for barrel storage (horizontal).
- 3. **Permits** SPLC 33.05 Permits This building has not received a Building Certificate of Occupancy from DSI Building Department. Contact DSI at (651)266-8989 to obtain final

approval of the following open trade permits and obtain a Building Certificate of Occupancy:
