## **Description of Variance:**

**Location**: The Lucky Palooza Event will take place on a closed portion of 7<sup>th</sup> Street West between Kellogg Boulevard West (174 7<sup>th</sup> Street West) and Walnut Street North (258 7<sup>th</sup> Street West) on March 11, 2017. **Noise Sources:** Visit Saint Paul has applied for a sound level variance in order to provide amplified outdoor music using electronically powered equipment at the recommended locations, times and decibel level limits (dBA) described below:

- 1. The variance shall be for the hours of 2:00 p.m. until 11:00 p.m. in the street on West 7<sup>th</sup> Street on March 11, 2017 outside Tom Reid's, 258 7<sup>th</sup> Street West and at Eagle Street/The Liffey, 174 7<sup>th</sup> Street West, and under the overhang in front of Cossetta's, 211 7<sup>th</sup> Street West; and in fully enclosed tents from 2:00 p.m. on March 11, 2017 until 1:00 a.m. on March 12, 2017 for a DJ/Live Music from tents at Burger Moe's Parking Lot, 242 7<sup>th</sup> Street West, Cossetta's Parking Lot, 211 7<sup>th</sup> Street West, and in McGovern's Parking Lot, 225 7<sup>th</sup> Street West during the Lucky Palooza Visit Saint Paul Event.
- 2. All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured at 50 feet from the sound sources outside on the street from 2:00 p.m. until 11:00 p.m. on March 11, 2017, and not exceed 80 dBA as measured at 50 feet from the sound source outside of the fully enclosed tents from 11:00 p.m. on March 11, 2017 until 1:00 a.m. on March 12, 2017.
