I also had an opportunity to speak with the construction Supervisor, who indicated that they would install a lateral sewer line terminating at the property line upon direction from the City, the water lines are situated together, they are staked, Larry, would you kindly confirm that the City will install the sewer line lateral and protect the water service? Please let me know at your first convenience.

Lastly, there's a single mature tree marked for removal, however, there are several more trees, in the right of way, between 76 & 92 Wheelock Parkway East, one of which is dead, and the remainder of which are one

Monti,

Thanks for your message.

On the vacation questions, Bob Novak in our Real Estate office can respond going forward. He's processing the vacation petition. He can also describe the "alternative procedure" to move forward with a vacation without the required signatures, but that is not an approach we like to take unless/until we know you've made every effort to solicit the support of the abutting owners. Further, that approach would need to include convincing your City Councilmember that the vacation is important enough to proceed without the other owners' support.

One other thought: If your intent is to acquire your neighbors' half of the proposed vacated right-of-way to the south and east of your property, and if your site plan will be showing driveways or other improvements on the neighbors' "half," you'll need to get their support at some point because they'll need to convey their "half" to you.

On your other questions about driveway cuts and sewer/water lines, you should contact city staff in the appropriate departments. I'd suggest starting with Larry Zangs in DSI who oversees the site plan review process.

Secondly, since the construction along Wheelock is commencing, and I wish to have a driveway how shall I preserve a driveway cut? Likewise, I'd like to tie in to the sewer in Wheelock, how can I get the City to provide me with such a tie in while the street is open, I'd like to do so, immediately, so kindly let me know at your first convenience. I also have identified two copper water lines terminating on the property, please insure that they'll not be damaged during street construction, as well.
