NOTICE OF PUBLIC HEARING

Shamrock's Irish Nook – St. Patrick's Day 2017 Sound Level Variance

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance:

Locations: 995 7th Street West

Noise Source: Shamrock's Irish Nook has requested a sound level variance, at a requested sound level limit of 100 dBA at no specified distance, to present amplified music within a fully enclosed tent with use of a sound system for a St. Patrick's Day Event on Friday, March 17, 2017 at 995 7th Street West. The variance is requested for the hours of 10:00 a.m. to 12:00 (Midnight), with a pre-event sound check at 10:00 a.m. on March 17, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance, within the fully enclosed tent shall be for the hours of 10:00 a.m. to 11:59 p.m., with a pre-event sound check at 10:00 a.m. for the St Patrick's Day Event on Friday, March 17, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured at 50 feet from all sound sources outside of the fully enclosed tents from 10:00 a.m. until 11:59 p.m. on Friday, March 17, 2017. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 11:59 p.m. on March 17, 2017.
