#### NARRATIVE

No ICC available.

On 11/4/2016 I, Squad 131 (C. Lesedi) was sent to United Hospital ER Rm #18 to take an assault report which had happened at 1183 University Ave. W., Arnellia's Bar, early this morning. When I arrived, I spoke to the comp., ROBINSON, CHANTEL RENEA (DOB 1/18/1991, 759 1/2 Monroe St., Anoka, MN 55303, tel. 612-384-3432). She was being treated in the ER for her injuries. She told me the following.

ROBINSON had participated in the Smack Fest at Arnellia's earlier in the evening (a competition in which willing contestants take turns slapping each other in the faces). She had competed against a B/F whom she has seen around but doesn't know. ROBINSON doesn't know her name but would recognize her if she saw her again.

After the Smack Fest competition, ROBINSON and her opponent spoke and neither one was upset by the outcome or talked about any further fighting. ROBINSON left the bar between 0200 and 0230 hours this morning and headed to her car. Once she got outside, however, her opponent, the suspect, took a different stance and wanted to fight ROBINSON. The suspect, her boyfriend, and 5 or 6 of her other friends surrounded ROBINSON at her car.

ROBINSON and the suspect started to fight. Then the boyfriend and the others joined in. She was punched in the nose and knocked to the ground where the suspect's boyfriend stomped on the left side of her face with his foot. The fighting continued until Police arrived. Then everyone else left and ROBINSON was the only one there.

She said the Police Officers came up behind her and tried to hold onto her. She thought the officers were the suspects again so at first she resisted. Then someone told her it was the cops and that she was okay. Then she calmed down.

ROBINSON said that she had bled a lot from her face and that a lot of blood had gotten on someone else's car. Someone lost their wig in the fight. She had a broken fingernail, and 2 false nails had been ripped off of the fingers on her right hand.

ROBINSON had significant bruising on both sides of her face. There were also scratches or cuts which had bled. The left side of her face was noticeably swollen. Her right eye was also swollen, red and bruised. She had a few light scratches and scrapes on her left arm and right wrist. She said some of the redness and bruising on the right side of her face was from the Smack Fest.

ROBINSON hadn't gotten any results back yet from the x-rays and CAT scan that had been done in the ER. She signed a Medical Waiver, which I later turned in to the Property Room.

ROBINSON described the suspect as a B/F with a light complexion, a pudgy nose, and brown hair in a pony tail. She was about 27 years old, 5'5" and 200 lbs, wearing a maroon shirt and jeans. The suspect's boyfriend who stomped on her face was about 6'2" with a heavy build, brown skin, about 27 years old, and wearing a black hoody. He may have had a tattoo on his face.
