2017 and beyond may see changes to water industry

Here at SPRWS we are preparing for 2017. We have a long term capital plan and a sound operation and maintenance program that has served us well for many years. That being said, we are always looking toward the future to stay in front of any pending regulatory changes or other legislative items that may impact how we need to operate the utility. This year and beyond may pose some challenges in that regard.

We have a new President and different majority and leadership in both bodies of the legislative branch following the elections last November. What will this mean for the drinking water industry? As in all political areas, there are already several differing opinions on this issue. As always, we will use our resources at the Association of Metropolitan Water Agencies (AMWA) and the American Water Works Association (AWWA) to keep on top of issues as they arise. We closely monitor the Environmental Protection Agency (EPA) to determine what regulatory modifications may be proposed and the federal budgeting process to ensure that one of our major funding sources (Drinking Water State Revolving Fund) continues to be funded at current levels.

SPRWS has supported AMWA and AWWA and many staff members have been involved at the local, state and federal level of these organizations. They provide us valuable tools to stay informed and to remain ready to meet the challenges and changes that may come up in the

To determine your balance, go to www.wealthcaread-min.com and select the participant portal to login. Questions? Contact CelioStar at 612-436-2778.

Remember, there will be two balances. The flexible spending money you set aside in 2016 must have been spent in 2016 and claimed by midnight Feb. 15, 2017. The website abbreviates that balance FSA.

The website lists the health account money you accrue from Healthy St. Paul as HRP. This money rolls over each year and does not need to be spent or claimed annually. If you have questions, call CelioStar at 612-436-2778.
