I am writing in response to your letter dated February 1, 2017. I have included copies of documents showing that my home is not a rental unit, therefore you have no reason to do an inspection on my home. I have informed you of this in the past. I have no idea why you continue to set up appointments. On January 1, 2017, my house was determined, 422 East Jessamine Ave, not a CO Bldg. On January 6, 2017, it was also determined that my home was not a rental, (17 001 428 CFO 00 CS).

I have also included a copy of a bill I received from *Saint Paul Regional Water Services*(SPRWS), which also has my name on the bill. As you know SPRWS only bills the homeowner.

There is also a copy of the, *Vehicle Abatement Order*, which is a code violation given to homeowner's, which has my name on it also.

The fire inspector that came to my home in January to inspect it, without notice, I was still in my night clothing made what would consider a sexual in nature statement, after I asked someone to get me a robe, "you don't have to put a robe on just let me step in". When I asked him for his card he said he did not have one. I really do not think that was very professional. I will be making the Attorney General's aware of his statement.

I have also included a copy of the Confession of Judgment I have with the Ramsey County Property Tax Department. I was told that nothing could be found that showed I had some connection to 422 E Jessamine Ave, clearly, I do. There is a Power of Attorney on file with the Ramsey County Property Tax division, which I am sure you can get access to.

I will be contacting the Attorney General's office regarding the harassment I have been receiving from the City of St Paul, and the statement of the fire inspector who came to my home. If there is a code that states, HOMEOWNER'S NEED TO HAVE A FIRE INSPECTION please forward that code to me so I can review it.


