Location: Outdoors at the Oxford Community Center Football Field, 270 Lexington Parkway North

Noise Source: Tawfiq Islamic Center has applied for a sound level variance, at a requested sound level limit of 80 dBA in order to provide announcements and prayer for the Eid-al-Fitr Muslim Festival at the Oxford Community Center Football Field, 270 Lexington Parkway North. The Eid-al Fitr Service is to be held on Saturday, June 24, or Sunday, June 25, 2017, from 6:30 a.m. to 10:30 a.m., with a pre-event sound check at 6:30 a.m. The Department of Safety and Inspections recommends the following conditions: 1) The variance shall be for the hours of 7:00 a.m. to 10:30 a.m., with a pre-event sound check on Saturday, June 24, or Sunday, June 25, 2017 at 7:00 a.m. 2) All electronically powered equipment used in conjunction with the event shall not exceed 75 dBA as measured 50 feet from any sound source used for prayer and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 a.m. on the date of the event.

If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.
