Noise Source: Minnesota Bicycle Festivals Inc. has requested a sound level variance, at no requested sound level limit or distance, in order to present amplified music and announcements located at 788 Grand Avenue for the North Star Bike Festival on Wednesday, June 14, 2017 from 4:30 p.m. to 9:30 p.m., with a pre-event sound check at 3:00 p.m. The Department of Safety and Inspections will be recommending the following: 1) Variance will be for the North Star Bike Festival located at 788 Grand Avenue on June 14, 2017. 2) All electronically powered equipment, PA system, loudspeaker or any similar device used in conjunction with the event, will not exceed 85 dBA, as measured 50 feet from any stage or sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices will be turned off by 9:30 p.m. on June 14, 2017. Recommended conditions may change before the date of the public hearing.

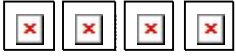
