You can start by implementing the 4th St leg of the bikeway. 4th St is important as it connects the downtown loop to destinations such as the Union Depot, 12 eyes Brewing, Central Station,

employment and other destinations. While there are concerns that 4th street would be redundant to a future leg on Kellogg, it would be no more redundant than any other 2 parallel streets in our current motor vehicle network.

I would also ask that you look at easy low cost implementation options such as flex posts and duct tape striping for short to mid term implementation until funding can be secured for full build out.

This is important for creating a livable, accessible and competitive downtown. The network that is planned and the portion that has been already built will set downtown St. Paul ahead of all other urban downtown areas in the US. Do what is right for the environment, city and world by helping finish this downtown network.

Thank you for all your efforts to date to implement the Comprehensive Bike Plan with fidelity in St. Paul. Ironically, downtown and the area around the capital of Minnesota are the most horrible places to bike in Minnesota. This is because downtown is isolated from all its neighborhoods by the freeway spaghetti and trenches of I-94, I-35 and State Highways 52 and 5. The downtown loop and spurs was designed to bridge these trenches and make downtown safe to bike in. BUILD IT ASAP. If you lack funds, then do some stuff on the cheap, on an interim basis. For example, just use some old jersey barriers to create a protected bikeway on St. Peter (as called for in the plan) from John Ireland to at least 10th street.
