Description of Variance:

Location: 2077 Ellis Avenue

Noise Source: Fair State Brewing Cooperative has requested a sound level variance, at a requested sound level limit of 90 dBA at 100 feet, to provide the use of a sound system for a DJ and amplified music at 2077 Ellis Avenue for the Mixed Culture event. The variance is requested for the hours of 4:00 p.m. to 8:00 p.m., with a pre-event sound check at 2:00 p.m., on Saturday, July 15, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 4:00 p.m. to 8:00 p.m., with a pre-event sound check at 2:00 p.m., for the Mixed Culture event on Saturday, July 15, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 100 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on the date of the event.
