Amending Chapter 376 of the Legislative Code pertaining to taxicab service company license applicant qualifications.

*Dan Niziolek gave staff report. This is housekeeping related to the taxicab ordinance amendments from last year. They wanted to allow for companies that were not there before. The City Attorney's Office said we needed a direct amendment specifying the criminal background checks to be done by owners.*

*Council President Stark said he talked to one of the company owners. There was a concern about a fee structure change on the second inspection. She asked is that before us?*

*Niziolek responded that one of the concerns in allowing taxi companies to do their own inspections was the high failure rate on first inspection. It was \$100 on the first inspection and then a free second. If they pass on the first one, they will not need a second. Then they were taking advantage of the free second. The first one was to figure out the issues and the second one is to get the passing. They wanted to look at the pass rate on the first inspection. Since the ordinance amendment, they are monitoring and seeing improvement on the pass rate for first inspection.*

*Stark said fee structure change is not here. Niziolek said it is not in ordinance in terms of fee structure. It will be done administratively.*

*The following spoke in opposition:*

*Mike Breckman, Yellow Taxi, has been with them for 32 years. He has been in attendance to almost every meeting in those years that the licensing department has conducted. He will utilize the word racist in this dispatch licensing to describe the inequality the license department has presented here. He is not the guy who deregulates the taxi business.*

*Council President Stark said to keep to the issue in front of us. Breckman responded the real issue is the transportation company being regulated. They want to add another license fee they don't regulate.*

*Kathy Windell, Citywide Cab Company, is opposed to this additional \$50 fee for this second inspection. Her cars pass, and she has never had problems with the City. It does not go far enough to ensure we have good equipment on the street. It is a little Band-Aid. \$100 for an inspection. If you don't pass, it's another \$50. It's a drop in the bucket. She asked DSI (Department of Safety and Inspections) to take a better look at the process.*

*Stark responded the actual change is to license the company instead of the drivers. Windell responded this is in reference to the \$50 fee. Stark responded that was part of the issue last year. Windell said it was discussed at their meeting two weeks ago. She does not understand why they have to have a company license. If there is a complaint, DSI contacts City Wide. There are companies with 24 hour cars. She doesn't understand why there is an additional fee.*

*Stark asked Niziolek for a brief answer. Niziolek said there was no last year service company license. We licensed the driver and the owner of the vehicle. You would have companies operating with other cars affiliated with them. We could not take action against the company because we did not license the company. We want companies to manage their fleet, and we want to hold them accountable for how they manage it. They now can train their own drivers, and we will hold them accountable. Before, we required them to go to one of the technical colleges to be trained. Now we are looking at them doing vehicle inspections. They can manage their own*

company.

*Councilmember Bostrom asked does this apply to companies like Uber and LFT. Niziolek said there is a separate ordinance for transportation network companies. They hold the company required for background checks, vehicle inspection. They are looking to the company to manage, and we do the audits to make sure they comply with the requirements.*

*Bostrom asked when Uber is inspected by someone, do we get that information? If a cab is inspected, do we get a slip that the cab has passed. Niziolek responded that taxicabs are done at the City garage. Any inspection reports, we get. Under the TNC (technical network companies) ordinance, they can use a third party. We do random audits, call up drivers, and reserve a ride. In addition we send some to the garage.*

*Bostrom said it is not the same as getting an inspection report on every car. Niziolek responded we do not get every report. Stark responded we are open to the City moving into that direction. Staff wanted to see a better pass rate on their inspections.*

Amending Chapter 414 of the Legislative Code pertaining to Massage and Bodywork Practitioners.

*Anyone opposed?*

*Katie Walters, Maplewood, MN, said for the current code, you are covered under the chiropractic license if you work for a chiropractor. She asked is that going to change. Tolbert responded this ordinance does not address that, so nothing is changed.*

*Walters said she is opposed to the national changing because it is only on city level. There are cities around here where you show your I.D. and you get a massage license. In Saint Paul, if you change this, you now require a national license. The test is hard and based for new massage therapist. After practicing for 8 years, she could not take the test tomorrow and pass. Someone could move to another city because it would be easier to get licensing. They could look at the current curriculum at St. Paul College. She does not know if they meet the national requirements.*

*Cory Han, Sister Rosalind Massage and Wellness Center, licensed in City for many years. Many therapists out of school are good at what they do. The City is looking at credentialing them. It is a level that is not needed. Massage therapy is intuitive. When they come out, many of their standards have already been met in the program. Having them work to obtain the national certification is too much. Some people who have come out of school are impressive. Of the cities around us, we would be the only one requiring this. If we are trying to set a standard to improve, this is not the way to do it. We should leave it up to the centers.*

*Councilmember Tolbert said the licensing process was cumbersome and took long; we are trying to expediate that process.*

*Dan Niziolek said this came out of conversation with the massage industry. They were talking about how long it took to license massage practitioners. Currently, you have to be nationally certified or pass a written test by the City and pass a practical test conducted by a contracted individual. That is 3 to 5 week process. The massage industry said it was impacting their ability to get massage therapists. They said national certification is too high of a standard. Also, the City system did not work. They came up with the exam and accredited schooling. There is legislation before the Legislature, but it's been there for a few years. \$500 is the bottom line. Saint Paul would like to get out of the business and rely on the experts. The schools are doing the training. We should be able to turn them around in 5 to 10 business days. They also do background checks. They looked at other standards around the country.*

*Council President Stark said he should have given the staff report first. Stark asked if the previous speakers want to say anything.*

*Han said Minnesota is one of the few states without national certification. They can understand the City wanting to get out of the credentialing. They should be credentialed after they get their certificate in the program. Adding another testing is still a test many people don't want to take. Saint Paul would be one of the few that would require this for a credentialing manner. Background check is good. Certification from a massage school is the only one thing they need. For hiring, it would be difficult. Not many are coming out like they used to be.*

*Councilmember Brendmoen asked how much debt a massage therapist has. Han said now it may be upward to \$20,000. The extra fees will be a burden.*

Brendmoen asked how much they make an hour. Han responded \$18 to \$21. Chiropractic is higher. It's about 25 hours a week maximum. Not a lot of people coming out of school that are getting the national certification or Mblex.

Councilmember Noecker said Mblex is one possible means and not required. Just completing the school is sufficient. Han responded absolutely.

Following are in support

Annette Rondano, Back Rub in Highland, said she hounded Councilmember Tolbert about this issue. It is hard to hire therapists because it takes so long to get a license. She finds people saying they do not want to take the time. They have to take two tests, scheduling is hard, and it is expensive. She was also on the advisory committee. She comes down on the side that a school that is accredited that is providing enough hours should suffice. They came up with the Mblex because some schools are accredited and some are not. Some are getting inferior training if it is not accredited. Any school can have a massage program, but it doesn't mean it is not accredited. She hires people from Centerpoint School Massage Therapy in St. Louis Park because the training is so thorough. It is the clinic hours that worry her the most. The Mblex is a good base. She agreed the City should not be credentialing therapists. We settled on the Mblex as a committee. It felt like that would be a minimum. If she had to take the Mblex, it would be hard, but she would study and take it. It could be the standard. People study for the test, they are more committed. She used to have a store in Minneapolis, but it was hard to keep people. She loves having a business in Saint Paul because of the requirements we have. She knows it is hard to get people. Massage therapy is moving towards medical. They are never going to get license in the State if people are not smart enough to be able to make sure they are not hurting people. It is complicated. It is not just about how much people can afford. She hired a lot of people and really supports it. If they do not go with the Mblex, it would not bother her a bit, as long as the schools are accredited.

Noecker said a graduate from an accredited school should not need an examination. Rondano responded they have a lot of examinations and a lot of clinical hours

Noecker asked about whether it is accredited versus not accredited. Rondano responded if she graduated from Centerpoint, she has had hundreds of clinical hours and it is almost an insult to take another test after all those hours. Most of her therapists have taken the state. 500 hours is not enough. It does not give you enough clinical hours.

Jennifer Sather, 1056 Winslow, says she is in support. It simplifies the process for the massage therapist. It does the hiring. It takes 3 to 5 weeks for a massage therapist to be vetted by the city. All the therapists should have a background, having them go through written and practical is time consuming. It is insulting to the therapists to have to prove themselves. The process should be simplified further. Scheduling the test for the specific computer has to be done on Tuesday or Thursday. This makes the process longer. They are pushing for a simplification of the process. She would agree with a background check and vetting process. She is in support of getting rid of the practical test.

Cari Pelava, owner and director of Centerpoint Massage and Shiatsu School. She was on the task force. She is concerned about educational requirements for this. A lot of graduates who live in Saint Paul and travel to St. Louis Park come to their school. The Mblex, Massage and Body Works Exam is very entry level, base education, should be able to be passed by professionals and new graduates. Accreditation is not a standard for quality or education. There are two types: 1)

*institutional – Many school are institutionally accredited, but they don't go through the program, 2) programatic – commission on massage therapy accreditation. They accredit only massage schools. They go through every minute of what we teach. They have to show outcomes. There are only two schools with programmatic education that is accredited. The standard in the industry now is the Mblex: Massage and Body Works license exam. It was decided because it would simplify the process in Saint Paul. Graduates and professionals could start working sooner.*

*Anyone else in support? No.*

*Diane Marshaman, works at Sister Rosalind. She is a business owner of DM Massage. She has a license in Falcon Heights. She is an independent massage therapist. She massages anyone 55 and over. When she got her license a year ago, all she had to show was her classes. She has 680 hours from National American University. She has a diploma. She quit childcare to pursue her dream. It took her four years to get a one year diploma. In obtaining that license, she had to show her hours and go through background check. The hours include CPR and continuing education. She is going to go for her national certification. She wants to work in nursery homes and be recognized, but not to be dictated by the City of Saint Paul. She took the written test and she had to take time off and it cost her. Also, she had to take the skills test. Again, taking time off and more money. It was a breeze to get a license in Falcon Heights.*

*Councilmember Tolbert moved to close the public hearing.  
Public hearing is closed.*

*Tolbert said they will vote on this next week. This will expediate this process. There may be future changes as well. There needs to be a good license in Saint Paul. It is a good compromise. A lot of this goes back before massage therapy was a legitimate educated trained thing. They are trying to get the old laws off the books. The industry has changed a lot in the last 20 to 30 years.*

*Noecker said she has heard about massage since she took office. This is trying to simplify the process.*

*Brendmoen said there is room to streamline this even more. We are open to continuing to do this. This is the first step.*

*Stark said it is a balancing act wanted it to be streamline and wanting to ensure that people's licensure means something and folks practicing in Saint Paul are not going to hurt people.*

They received about \$90,000 from MNDOT. They send in landscape architects to repair the entire strip from Grand Avenue to St. Clair. The neighborhood provides all the labor. It is a 3.5 year process. So far, the first two phases, they planted over 1500 new plants and trees along that trail. They are low growing plants so they do not have cover for encampments and they work as a pollinary habitat. They also received a grant from the Minnesota Pollution Control for the tree truck program. They have special signs to scan to tour all the trees in the neighborhood. This approval is the final step. The new crosswalks on St. Clair are important for safety. Reuben has been fantastic to work with.*

*Darren Tobolt, lives in Bohemia, wants to second everything Mark said. It has been a fantastic project. This is increasing public safety. Keep working and going along the 35 trail. For the next neighborhood down; it is still a problem with the homeless encampments.*
