WHEREAS, The City and the Board, are the beneficiaries of that certain perpetual easement to divert, take and draw water from Lake Baldwin in the County of Anoka, State of Minnesota, which easement is set forth as a recital on the certificates of title for the real property legally described on the attached <u>Exhibit A</u> (collectively, the "Burdened Property"), and which easement reads as follows:

...a perpetual easement held by the City of Saint Paul and Board of Water Commissioners of the City of Saint Paul to divert, take and draw water from Lake Baldwin in the County of Anoka, State of Minnesota, to supply the inhabitants of the City of Saint Paul.

(the "Easement").

**WHEREAS**, the City and the Board, for themselves, and their successors and assignsforever, have resolved to forever release the Burdened Property from the Easement.

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the City and the Board each hereby declare as follows:

- 1. <u>Recitals Incorporated</u>. The Recitals set forth above are hereby incorporated by this reference and shall be deemed terms and provisions hereof with the same force and effect as if fully set forth in this Section 1.
- 2. <u>Release of Easement</u>. The City and the Board hereby release the Burdened Property from the Easement, and hereby terminate all right, title and interest the City and the Board have in and to such Easement upon the Burdened Property.

- 4. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which shall constitute an original, and all of which, when taken together, shall constitute one and the same instrument.
- 5. <u>Severability</u>. If any provision of this Agreement or the application hereof to any person or circumstance is or shall be deemed illegal, invalid or unenforceable, the remaining provisions hereof shall remain in full force and effect and this Agreement shall be interpreted as if such illegal, invalid or unenforceable provision did not exist herein.
- 6. <u>Successors and Assigns</u>. This Agreement is binding upon the parties hereto and their respective successors and assigns, and shall benefit the owners of the Property, their successors and assigns, forever.
- 7. <u>Governing Law</u>. This Agreement shall be governed by the laws of the State of Minnesota.
- 8. <u>Recordation</u>. The parties consent to the recordation of this Agreement in the property records of Anoka County, Minnesota and to the deletion of the reference to the Easement from the Certificates of Title for the Burdened Property.
