Ms. Vang, I am sending this letter of status requirements for 855 Lexington Parkway South. I am enclosing a letter from Marco Velasquez, Asst. VP of Alliance Bank of Arizona that identifies the amount of unencumbered deposit I might need to fund the remodel of the subject house. This amount can be adjusted up if needed.

I apologize for not having all the requirements for the work plan but we have made considerable progress. We can provide the names of persons responsible for each aspect of the project as soon as we can confirm all of details of each bid.

I have attempted to call Matt Doran and Jim Seeger multiple times. Matt informed me last week the project was in Jim's hands, so I have been trading calls and messages with him for a week. The issue was not having the combination of the lock to access the interior. I had previously told or left on voicemail the combination was on the back of the clock to make access easier. The rehab budget seems to be a reasonable amount to fix the house to current code. This is only the initial estimate and will try to have confirmed ASAP. I have also taken the precaution to get two demolition bids to have a backup position.
