Locations: Harriet Island Regional Park

Noise Source: Midwest Renewable Energy Association, represented by Leon Dulak, Site Manager, has requested a sound level variance, at a requested sound level limit of 90 dBA at no specified distance, in order to provide amplified music and the use of a sound system, during the Energy Fair MN Event, from 5:00 p.m. until 9:00 p.m. on Friday, September 8, from 1:00 p.m. to 2:00 p.m. and from 6:00 p.m. until 11:00 p.m. on Saturday, September 9, and from 12:00 p.m. to 2:00 p.m. on Sunday, September 10, 2017, with a pre-event sound check at 10:00 a.m. each day. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for the hours of 5:00 p.m. until 9:00 p.m. on Friday, September 8, from 1:00 p.m. to 2:00 p.m. and from 6:00 p.m. until 11:00 p.m. on Saturday, September 9, and from 12:00 p.m. to 2:00 p.m. on Sunday, September 10, 2017, with a pre-event sound check at 10:00 a.m. each day. 2) Small Venue Sound System inside Main Stage Tent and Pavilion to be used on September 8, 2017, Keynotes and Music on Medium Venue Sound System to be used inside Main Stage Tent and Pavilion on September 9, 2017 and Small Venue Sound System to be used inside the Main Stage Tent and Pavilion on Sunday, September 10, 2017. All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA at 50 feet from the sound source. Stage amplified sound to end at 11:00 p.m. on Saturday, September 9, 2017 per Parks Department end time Policy. 4) The applicant shall provide personnel and equipment who will provide continuous sound level monitoring at each sound source during the hours of the variance. 6) All electronically powered equipment, PA systems, loudspeakers, or similar devices located on the event grounds must be turned off no later than the above identified times at the specific locations on the event dates.

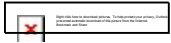
A public hearing before the City Council on this variance request will be held on:
