**Location:** Xcel Energy Center, 199 Kellogg Blvd W, Gate 1

**Noise Source:** Flannel Athletics has requested a sound level variance, at a requested sound level limit of 90 dBA at no specified distance, to present amplified music and sound system announcements with a DJ for a Start and Finish Line for the Minnesota Wild Breakaway Run. The variance is requested for the hours of 7:00 a.m. to 10:30 a.m., with a pre-event sound check at 7:00 a.m. on Saturday, September 16, 2017. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 7:00 a.m. to 10:30 a.m., with a pre-event sound check at 7:00 a.m. for the event on Saturday, September 16, 2017. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 a.m. on the date of the event.
