While I was there I was very active in my community, in fact, I served as a board member of the Payne Phalen Community Council. During my tenure, I found that there was greater support for bicycle infrastructure on the East Side than people generally thought outside of the neighborhood.

There have been a few outspoken neighbors or businesses that were opposed to bike lanes, but in general, residents of the East Side liked the idea of cheap infrastructure that empowers the community to live more sustainable lives.

I knew many East Side cyclists (myself included) were not biking for the sport of it, but rather because our economic reality required it. It is to that economic reality that I want to draw your attention today.

I am disappointed that the city council initially killed the Stillwater Avenue Bikeway and I am disappointed in the way in which they killed it. I hope the council reconsiders and approves this bikeway.

I testified in favor of the project at the August 16, City Council public hearing and I want to correct two false statements that I heard about the project from one of the Council members and someone who testified at the hearing. The first statement I heard was that "Stillwater Avenue is unsafe for children so we should relocate the bikeway to Case Avenue." The second statement was that "Stillwater Avenue doesn't connect to anything."

The first statement is completely illogical because Case Avenue is ALREADY on the Saint Paul Bikeways Plan as "enhanced shared lanes". This statement told me that none of the opponents of the bikeway bothered to actually look at the Bikeways Plan--

Stillwater Avenue is a different facility and is meant to be complementary to Case. Stillwater is in-street bike lanes for adults who wish to get places or go on longer recreational rides. While Case Avenue ends at Beaver Lake (and has no connections to the east), Stillwater Avenue continues east to other towns and both it and Lakewood Drive are designated off-street bikeways on the Ramsey County Bikeways Plan (see link below). Like the Saint Paul Bikeways Plan, the Ramsey County bike plan was the result of a multi-year planning process in which I and many others participated and with which Saint Paul city staff have tried to coordinate--

What most bothered me about the last city council public hearing was listening to council members who clearly hadn't read the city's Bikeways Plan, hadn't bothered to look at Ramsey County's Bikeways Plan, hadn't bothered to read the Public Works parking utilization study of Stillwater Avenue, and didn't bother to call staff back up to clarify any of their mis-perceptions and mis-characterizations. The Bikeways Plan has been out since 2015 and this project had at least one

open-house, sent out notices to neighbors and had on-line, written and email comment opportunities. To ignore all this and then kill the project, at the last possible minute is a huge waste of staff time, volunteer time and public money. If council members had a problem with the project or wanted it redesigned, they should have brought it up with staff months ago and not allowed it to come to a public hearing. I urge those council members that voted against this bikeway to reconsider their positions and their votes.

Jane,

I'm sorry I missed you last week when you stopped by to discuss the proposed bike lanes on Stillwater Avenue. As someone who drives, walks, and cycles Stillwater on a daily basis, I wanted to give you my take on the proposed lanes.

Just so you know where my perspective is coming from, I'll give you a little history about how I got into cycling.

I cycle 3-4+ times a week. I moved to the east side from an area that had many off-street paths, which was where I did most of my riding at the time. After I moved here, and due to the lack of bicycle infrastructure on the east side, I had to learn how to ride my bike in traffic. It was quite frightening at first. As my confidence grew, I started riding busier and busier streets and eventually had the courage to start using roads with bike lanes such as Ruth, Johnson, and Summit. Fast forward a few years, and I now consider myself a fairly confident rider. But even to this day, I am hesitant to ride down a busy road if there isn't a bike lane on it. One of the arguments I hear from people that oppose bike infrastructure on the east side is that "no one bikes here". I can't really say those people are wrong. There are certainly fewer cyclists on the east side than in other parts of the city, but we should really be asking ourselves why the numbers of cyclist are so much lower on the east side. In my opinion, it is due to a lack of safe places to ride a bicycle. I firmly believe that if the infrastructure is put in place, more and more people will gain the confidence they need to use that infrastructure. There are many studies out there that back up my belief. In my experience, I have found one of the biggest conflict points between motorists and cyclists to be unpredictability on the cyclist. Cyclists make motorists nervous because they have trouble predicting what path the cyclist is going to follow as he/she is riding in the road. A bike lane makes for a clear visual representation on where the cyclist should be, which reduces conflict and anxiety in both the rider and driver. This is the reason why I try and stick to roads with dedicated lanes.

So now that you know my position on bike lanes, I suspect it will be no shock to you that I fully support the proposed lanes on Stillwater. I was disappointed to read your comments that stated that you "didn't feel the lanes connected to other bike facilities" and I disagree. To the northwest of Stillwater, there is the pedestrian bridge over the RR tracks that connects to the Old railcar trail which takes you all the way to the city limits on Larpenteur. Maplewood also just completed a trail from the terminus of the Old railcar trail on Larpenteur north to a block short of 7 ave in North ST Paul (which also just received bike lanes) and the Gateway trail. To the east, there is the trail that runs down Stillwater on the Oakdale side which is a very popular return route from Stillwater that connects to other trails to the east like Hadley and Helmo. There is also the Mcknight trail to the east. To the south is the Ruth street bike lanes, which would greatly benefit from the N to S connection to the Old railcar trail. To the west, well, there's not

much there. It's one of those huge gaps in infrastructure that the East side is known for. A safe way to ride to Phalen would be amazing. I'd be happy to bring you on a bike tour of the area sometime to point out these connections.

One of the other benefits of bike lanes would be the narrower lanes and the calming effect they provide. This is one of the huge benefits I have noticed on Upper Afton. That road used to be a racetrack, and since the lanes were narrowed, things have slowed down significantly. Stillwater, like most of the streets in STP has it's share of speeders. As you know, it is also a truck route. I have never seen a (semi) truck speed down the road. I find these drivers to be professional. Ruth street is also much busier. The bike lanes work just fine on Ruth.

As far as the parking issue goes- The data shows an extremely low usage rate. My antedotal daily-observations back up this data. Most of the businesses along the route have their own lots. Are we really going to let a 9% usage rate kill a project? I realize the usage rate is higher in spots, but I don't believe this should be a deal breaker.

Sorry for the length of this, I hope you will reconsider your vote when this issue comes back up.

Dear Rob,

The Saint Paul Bicycle Coalition has met every month for almost eight years. A lot of people including myself have put in thousands of hours of their time trying to get and implement a city-wide bike plan. Despite being on the SPBC mailing list since our inception, you've shown up just once, nearly eight years ago to get us to turn out for a District Council hearing and vote on Furness Parkway. We did and, at your request, we wrote to city officials urging them to approve it.

Now, at the last minute, having not participated in any discussions, you appear at a public hearing and help convince Council Members Bostrom and Prince to kill a funded bikeway that would connect to Furness Parkway, that was approved on the city's Bikeways Plan in 2015, that held open-houses, sent out notices to residents and businesses and used up hundreds of hours of volunteer time, staff time and public money-- money that you and I pay for in property taxes.

Your reasons for doing this are illogical-- that you prefer Case Avenue for "children" and that "Stillwater doesn't connect to anything." Case Avenue is ALREADY on the city's Bikeways Plan as "enhanced shared lanes"

(see link below). If you worked to get it funded and striped instead of blocking other bikeways, then children could ride on it all they want--

Stillwater Avenue is a different facility. It is in-street lanes for adults who wish to get places or go on longer recreational rides. While Case Avenue ends at Beaver Lake (and has no connections to the east), Stillwater Avenue continues east to other towns and both it and Lakewood Drive are designated off-street bikeways on the Ramsey County Bikeways Plan (see link below). Like the Saint Paul Bikeways Plan, the Ramsey County bike plan was the result of a multi-year planning process in which several people from the SPBC participated and with which Saint Paul city staff have tried to coordinate--

What's more, Case Avenue only goes as far west as Johnson Parkway, at which point, a rider wishing to go downtown still has to head south to Margaret or Reaney. For an adult bike commuter trying to reach downtown, why would I want to ride north to Case and then back south when I could just ride south from Stillwater Avenue on Hazel or Flandreau?

Under your leadership, the old Bicycle Advisory Board became totally dysfunctional, accomplished almost nothing and was disbanded. Since then, you've operated in a vacuum, in your tiny corner of the city and have made almost no effort to reach out to or communicate with other cycling advocates. Now, for bizarre reasons, at the last possible minute, you've helped to kill a funded bikeway on which a lot of volunteer and staff time (and money) was spent. Good advocacy requires communicating with other people. What you did was a disappointing, frustrating waste of everyone's time and money.

Are there alternative streets with a lower traffic volume and slower speeds that would work and without impeding traffic or creating unnecessary risk?

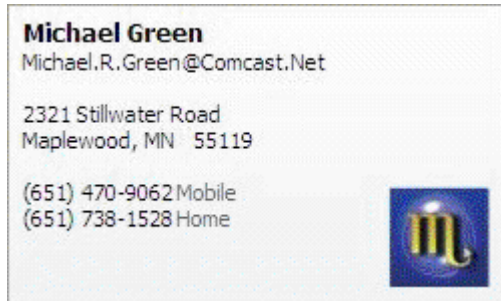
Case Ave perhaps?
