NOTICE OF INTENT TO REVOKE LICENSES

Dear Ms. Ortega:

The Department of Safety and Inspections (DSI) has recommended revocation of the Malt On Sale (Strong) and Wine On Sale licenses held by Ortega Enterprise, LLC d/b/a Sonia's Steakhouse for the premises located at 990 Payne Avenue in Saint Paul. The basis for the recommendation is as follows:

On July 24, 2017, the Department of Safety and Inspection (DSI) received a <u>NOTICE OF LICENSE</u> <u>REVOCATION FOR DEBT</u> from the Minnesota Department of Revenue requesting license revocation for an overdue tax liability.

Minn. Stat. § 270C.72, Subd. 1 states: "The state or a political subdivision of the state may not issue, transfer, or renew, and must revoke, a license for the conduct of a profession, occupation, trade or business, if the commissioner notifies the licensing authority that the applicant owes the state delinquent taxes payable to the commissioner, penalties or interest."

As a result, the Department of Safety and Inspections will revoke your Malt On Sale (Strong) and Wine On Sale licenses as of September 1, 2017, unless you resolve your tax delinquency and DSI receives a Clearance Certificate from the Minnesota Department of Revenue.
