My husband and I are also architects and care deeply about good design for both neighborhoods and buildings.

Why do we support the plan?:

- 1.If we are really about "welcoming all", we need to practice what we preach. I firmly believe that this site is an asset for all of St. Paul.
- 2. Although I initially voiced a concern about traffic—I have adjusted my perspective. Ford Pkwy has had reduced lanes nearly all summer. The world hasn't come to an end as people adjust their patterns. Yes, people adjust and adapt. In fact, it could be that more traffic may actually make it safer for pedestrians because vehicles will be forced to go slower, making them more aware of their surroundings. May seem like an odd thing, but this opinion was voiced a community meeting on the subject and it made me see the issue differently.
- 3. Right now, if we are driving to the airport (a common thing for me!) or anywhere south, we go through the Ford Pkwy and Cleveland intersection. We have met in person on a couple of occasions, mostly around the Earned Sick and Safe Time effort. I will be part of the group from ISAIAH meeting with you on the 27th this month. That meeting will be about other concerns, but I did want to get my thoughts about the Ford Site Redevelopment Plan to you

...

I think the plan is a good one for the most part. I was glad to hear of your amendment to reduce the height of the apartment towers. The size of buildings, as originally proposed, was too high. Nothing should be as high as the two towers currently present; new construction should be at least a few stories shorter.

The concern about traffic is a legitimate concern. I think the high-density, transit-favoring plan can work. However, for it to work, some things will have to be done to make it easier to use transit than a personal vehicle. As things stand now in the Highland Village area, if I were to stop at Half Price Books and then decide to have lunch at Panera and maybe run to Walgreens for something, I would have to move my car from parking lot to parking lot ... unless I were able to find an open street spot where I could park for up to two hours (which might not be quite enough time for all that). This is a significant

piece of traffic congestion at Ford and Cleveland. If you stop at one place, the expectation is you only go to that one place and you move your car to the next one. This dynamic must be changed. I would suggest putting in a parking garage around Ford and Finn. Another one might have to be put in around the library/community center. Although this would take out at least some of the athletic fields there, I think those and the current Ford baseball fields could be relocated within the proposed development. (And I do support retaining the current amount of athletic field space, but perhaps not in current locations) There should be a charge for parking in the structures; however, the parking receipt should also be used as a pass for free rides on a circulating shuttle in the Village area. This circulating shuttle is the key. It should stop at any parking structures, shopping/business areas, a couple of places central within the new residential development, one of the northernmost stops for the 46 bus on Cleveland, and every A Line stop between the Ford development area and the library/community center. (I don't see any need for it to go any further east than that.) While a partnership with MetroTransit would be needed, the shuttle should look distinct from regular city buses (maybe one of those bus vehicles made to look like an old fashioned trolley) and it could run on natural gas or electricity. The purpose is to make it easy for someone coming to the Village to park a car and leave it in one spot as well as for residents to access existing transit lines. It could also make it more attractive to take transit options to the Village. When weather permits, bike rental kiosks (or Nice Ride stands) at the parking structure(s) might make a useful feature as well. If you make it easier for people to move around by transit than by personal vehicle, they will opt for transit; however, so long as a personal car is easiest, that's what they'll do.

I really like the green space ideas of restoring the creek that feeds Hidden Falls and the biking/walking greenway area along it. I also think inquiries should be made to see if some rails-to-trails funding can be used to redevelop at least part of the old railroad spur into a bike path. In the Ford site area, it would be quite simple to connect with the existing path along the river. But to the west, it wouldn't take much to connect a bike trail in the rail spur area with the existing bike corridor along 35E.

As for the businesses, obviously, big box retail or major grocery stores are out of the question (or should be!). Some small scale, boutique-style retail that complements the existing businesses would be okay along with some restaurants and cafes on the scale of what is already present. However, I don't think retail and restaurants should be the bulk of business development. There may be a market in the city for small-scale office space (operations that require less than a floor of a standard office tower) as well as "office pod" space. (The company I work for has closed the office in Florida; staff in that location work from their homes or from one of the small collection of cubes the company rents from an "office pod" operation.) Having operations that offer employment that are not retail or restaurants would do a lot to foster the "live here/work here/play here" goal the plan seems to be designed to foster. As for the residential development, homes should fit the existing housing profile in Highland Park. (No McMansions or luxury lofts!) To improve density in the transition zones from apartment units to single family homes, consider duplexes or even quadplexes. (There are already a fair number of duplexes along Ford.) As for the new apartment buildings, units should be larger size. There are already plenty of one-bedrooms and studios. There is also a lot of senior-only housing in the area. Please make sure the new developments are family-friendly with larger apartment units (2 bedrooms minimum, but some 3 bedrooms with a flex space area). The Star Tribune had an article on September 2nd with some interesting ideas for apartment design (http://www.startribune.com/sunday-conversation-to-designdense-housing-take-a-cue-from-the-dutch/442489263/) I think townhome developments, with multiple bedrooms and a den in each unit, should be included in the mix of residential development. Whether rental or owner occupied, prices should be affordable on the median household income for Saint Paul. I would also suggest requiring landlords to accept Section 8 vouchers, especially if they want any TIF considerations.

As a token of good faith toward the existing Highland Park neighborhood, the city council could

prioritize properly repairing the section of Cleveland south of Ford ... and maybe enforcing speed limits in the area.

I am writing to you to implore you to please continue supporting the plans for developing the Ford Plant into a high density urban living space. I have lived in the Mac-Groveland neighborhood for 5.5 years and work as a parent educator with St. Paul ECFE on the Eastside. I see the benefits of making our neighborhood more welcoming and affordable to people who do not look like me, whose jobs don't afford them the luxury of owning a home and/or a car, or who simply prioritize living in a high density area where public transit is easily accessible and they can walk or bike to their local stores and restaurants because that is a value they have.

I understand neighbors' concerns about increased traffic and think that concern is valid. However, I think much of the potential increase in traffic could be mitigated greatly by ensuring higher frequency bus lines into and out of that specific neighborhood, and by intentionally making that space bike-friendly with safe bike lanes and walk-friendly with ample sidewalks and crosswalks. This problem could also be mitigated further by ensuring businesses in this new neighborhood include grocery stores and home goods stores that are walk-/bike-able for most living there.

I also hear neighbors' concerns about high-rises. I heard Melvin Carter speak at a neighborhood meet & greet last night. One of the things he said about the Ford Plant really resonated with me. St. Paul is rather land-locked. We can no longer build out; we have to build up. I think 'building up' is a reality we all have to face and come to terms with. St. Paul already has thousands of single family homes. Mac-Groveland and Highland Park, specifically, have thousands of single family homes compared to the number of multi-family homes and apartment buildings. Here is why:

- It is a rare opportunity to provide a chance for more people to enjoy living near the river, the trails, employment centers, colleges, hospitals and clinics, schools, a library and retail.
- Many people prefer to live in places they can walk, bike and take transit where they need and want to go. This trend is increasing, so we should provide more of this type of housing.
- Population is increasing and it would be irresponsible to keep expanding the suburban areas. We should add houses near the city centers. The commute times, environmental impacts, and infrastructure costs are a just a few problems that would occur if we continue to build further out in the suburbs. St. Paul has an opportunity to be part of the solution by adding housing density at the Ford site.
- It is an opportunity to provide a variety of housing stock for a wider range of income and ability so all people can live in a Livable Saint Paul. (not everyone can afford to or has the interest, skills or physical ability to maintain a home and yard.)
- It provides a place for people who currently own single family homes to downsize in their own neighborhood when they want or need to.

- 10-story high-rise buildings: There is a small area of the plan that is zoned for a couple of taller buildings. We already have a few taller buildings in the neighborhood and they do not block views substantially.
- New Park and Greenspace: Who would pay for the new park and greenspace? both the clean-up and the maintenance? Do they want to raise Saint Pauls taxes which are already higher than other communities in the metro area? I love parks, and in other communities I might agree that the best use of available land is parks but we are very lucky in the neighborhood, the Twin Cities and the State to have a lot of parks and open space that have plenty of capacity for increased use.
- Traffic: Congestion is not bad in Highland Park now. I trust that the plans will continue to evolve to manage traffic and congestion as we monitor trends. I support mixed use development, and for the most part I support the Ford Plan. I think it will bring a lot to the community and give us our own little downtown. We are excited to have many new amenities within walking distance.

My two concerns with the current plan, and the only things that prevent me from supporting it, are:

- 1. Building Height
- 2. Density

Building height has been primarily addressed with the amendment you proposed, which I fully support. Can you elaborate on exactly how much more green space would need to be allow buildings to reach ten stories? I'd prefer just to have the buildings all capped at six stories with no exceptions, but if meaningful green-space is added I may be supportive.

Density is another matter. Reducing building height will reduce density slightly, but I was hoping the number of residents would be closer to 5,000 rather than the anticipated 7,000. The latter number seems very large. I'm not sure what can be done about that. More green-space may again the answer. Even if green-space doesn't fully reduce the number of residents, it gives us all more public space and makes the area feel more open.

Overall, with your amendment, I'm very close to supporting the plan. If there was a way to reduce density or fully cap the buildings at 6 stories I'd prefer that. But your amendment seems like a reasonable compromise and I appreciate you listening to residents concerns.

## Councilmember Prince,

This has simply devolved into a game of 'whack-a-mole', when someone becomes enamored with a concept like 'density', and the residents most directly affected by it, the ones that you are elected to represent, must remind you again and again of the problems posed.

I guess that there is a limit to how much time we can take away from work, from family, or from other activities until 'one side' prevails due to exhaustion.

Simply put: It is completely irresponsible to approve high density T3 zoning for the section of Snelling Avenue, between Ford Parkway and I-94, until the effects of the new, under construction, professional soccer stadium, and the proposed, but not fully determined, Ford plant site redevelopment, at either end, are known.

'Known', not 'speculated'.

Due to the high-density use and occupancies proposed for these endpoint locations, T3 zoning along Snelling could redefine the 'perfect storm' of poor urban planning.

Last week I was in Boston, visiting family, and was struck how cities like that would give anything to allow residents to park in front of their homes; to unload groceries; to invite friends over, without having to walk blocks in the winter.

Today, I was stuck in traffic on University Avenue, recalling how this is NOT what makes a city 'livable'. Ironically, I was patronizing a business which had to move off of University Avenue, after more than 50 years, due to real estate pressures from the Green Line.

Increased density is not bad, but it should not be pursued for its own sake. Density should also not be concentrated in one area, in a manner that destroys its appeal, just for short-term profits or tax assessments.

T2 zoning would allow expansion of the moderate density architecture styles along Grand Avenue, Dayton, Portland, etc., with grass, multi-family units, and mixed-use occupancies. This could continue with the redevelopment of Snelling Avenue north of University to benefit larger parts of the City. It would not create concrete neighborhoods, imposing walls, and solar barriers.

Should a unique development be proposed that requires T3 zoning along this route, appeals and variances can be made through proper channels and reviews to allow it. But voting in T3 zoning without

any knowledge of specific plans, means that the City, and neighboring residents, may be forced to accept any such development, regardless of how disruptive.

A basic principle of medical care is 'first do no harm'; it should apply to zoning in this case. Speculating on T3 zoning, without knowledge of the effects from MLS and the Ford plant, opens this part of Saint Paul to catastrophic congestion failure. Waiting to see the results of these endpoint developments, allows us to still make good choices for Snelling Avenue and Saint Paul as a city.

I ask you to vote 'NO" on T3 zoning for this section of Snelling Avenue.
