The tobacco industry has a long history of targeting youth, African Americans, women, and LGBTQ individuals with its promise of a refreshing, cooler taste than non flavored tobacco products. I was at the public hearing last night, with my 11 year-old granddaughter, in regard to the proposed ordinance to restrict the sale of menthol tobacco to adult-only tobacco stores. I was taken aback

and highly offended by the comment made, "that this doesn't cost the people in the green shirts anything". I say, **HOW DARE HE.**

Most of them said 40 to 50% of their tobacco sales come from menthol products. We know that 88% of African American's who smoke, smoke menthols, which means the majority of their customers are African American.
