As a parent, I want my children to stay away from tobacco, but that is my job as a parent. I am responsible for ensuring they make healthy decisions, not the city council.


Currently St. Paul has a 97 percent compliance rate for not selling to minors. There are successful regulations in place to keep tobacco out of the hands of minors.
