Subsequent pictures I received from my client, taken in late June, appeared to show the property had been cleaned out. I recall from the hearing that the Safety and Inspection Dept was to go to the property to verify whether it was cleaned out. Has this condition been verified yet? I would like to know if it is acceptable in its current condition, or my client needs to do more work.

While I do not believe this will become an issue, if we have met the clean out deadline in a timely manner, and for some reason the Safety and Inspection Dept is unable to complete the Code Compliance Inspection Report before August 2, I would expect the matter to be recommended for a continuance for a reasonable time to accommodate the inspection process. In any case, please let me know if your office intends to recommend against the continuance at the August 2. Otherwise, I believe we are all on the same page.
