Subject: Chicken Ordinance

Hello, My name is Eric Saathoff, and I have chickens at my home in the Payne-Phalen neighborhood (Ward 6). I am writing to ask you to support the ordinance allowing up to 6 chickens without needing the approval of neighbors but rather simply by notifying them.

We have a permit for 11 chickens but currently only keep 9. Our chickens make next to no noise, no smells, and are otherwise not bothersome to neighbors in any way.

It was a struggle for us to get the signatures for our chickens - not because anybody said "no" but because we routinely had people who wouldn't answer the door when we knocked. Additionally, when we finally got enough signatures we were sent back out by Animal Control because we hadn't also gotten telephone numbers. One neighbor was quite unhappy to be bothered about it a second time. We persisted because we were committed but also in part because we were comfortable doing so as a white, English-speaking family.

Requiring people to get permission from each neighbor (at least 75%) not only discourages some people from having chickens at home but also encourages people to keep chickens illegally. Many of my neighbors have a limited English speaking ability, and the need to communicate their request to so many neighbors is a significant hurdle.

Since the City currently does not require neighbors to approve the keeping of dogs or cats, why should it be different for chickens? Dogs can be quite loud, unlike hens. We have regulations in place

that coops be built away from the property line and residential structures to reduce any nuisance effects that might come up. DSI has already reported to the council that complaints are minimal for homes with fewer than 7 chickens.

While it's true that we live in the city rather than on farms, "urban agriculture" can have significant social, health, and economic benefits for our people. For some it's a hobby while for others, such as our many immigrants, it is a way of life. As a city we should be encouraging personal and community gardens as well as chicken keeping.

Our city is encouraging residents to compost and recycle, and keeping chickens kickstarted our home composting. Currently we throw almost no food scraps away because we save it all for the chickens to eat. It is an excellent practice to reduce waste in exchange for healthy food (eggs) and cost savings.

Again, the city should encourage chicken keeping and reduce barriers. Please support the ordinance to ease the entry to chicken keeping in Saint Paul.

Subject: proposed amendments in regards to keeping of chickens

Council Member Tolbert, Our names are Stephanie and Drew Skwiers-Koballa and we live in the South Como neighborhood of Ward 5.

We are expressing our support for the recently proposed amendments to the city ordinances in relation to keeping of chickens. Owning chickens can be a component of a family's ability to provide fresh and healthy food for themselves. We have several garden beds and have seen the positive impact that having fresh food grown directly on our lot has had on our health. Earlier this year we became interested in keeping chickens as we began familiarizing ourselves with the responsibility of caring for a small urban flock and the steps necessary to legally license them. Keeping of chickens does require a level of responsibility and the permit requirements should be commensurate.

Homeowners in Saint Paul for seven years, we are no strangers to the importance and intricacies of safety and inspections to the city. In 2012, we built a deck on our house that required a variance and signatures of all nearby neighbors since the permanent structure could impact the value of their property. For this very reason, the amendment of most interest to us is the removal of the 150 foot radius of signatures required to keep a flock of 6 or fewer chickens.

It wasn't easy getting neighbor signatures for the deck, despite the plans being clear that it would improve our neighborhood. Not only is it difficult to get some neighbors to answer the door, but several houses within 150 feet are hostile to the neighborhood due to their previously reported illegal activities. I would love to say that in a Saint Paul neighborhood we would all be better off if we would talk to our neighbors more – but that is an idealistic oversimplification of a community. In reality, each property should be granted leeway to exist in a manner that does not detract from the quality of the neighborhood.

None of the proposed amendments reduce the authority of animal control or safety and inspections to cite a property that fails to adequately care for their animals or meet building and property codes. These are better channels to moderate anyone who chooses to keep a small flock of chickens in a manner that would negatively impact their neighbors.

We understand farmland can be obtained outside of the city for those who would like more leniency in regard to their urban agriculture. It is also important to understand that subdivisions with protective covenants and a home owner's association are also available for those who desire to be less impacted by their neighborhood.
