WHEREAS, on November 4, 1972 the City was granted a non-exclusive easement for ingress and egress purposes, as documented in Ramsey County property records Doc. No. 1844694 (the "1972 Easement"), over the real property described in <a href="Exhibit A">Exhibit A</a> attached hereto and located at 1645 Energy Park Drive, Saint Paul, Minnesota, Parcel ID No. 28-29-23-14-0002 (the "Private Property"); and

WHEREAS, the 1972 Easement was used by the City's Department of Fire and Safety Services to access adjoining city property located at 1675 Energy Park Drive, Saint Paul, Minnesota, Parcel ID No. 28-29-23-14-0006 (the "City Property"); and

WHEREAS, on April 28, 2006 the City was granted a non-exclusive easement for access purposes over the Private Property, as documented in Ramsey County property records Doc. No. 3952785 (the "2006 Easement"); and

WHEREAS, the 2006 Easement reflected a re-routed easement area within the Private Property to facilitate new development on the Private Property; and

WHEREAS, the owner of the Private Property has requested the City's release of the 1972 Easement and 2006 Easement to facilitate additional development on the Private Property, and the City has agreed to the request as there is no longer a need to access the City Property across the Private Property;

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City hereby agrees as follows:

- 1. <u>Recitations</u>. The foregoing recitations are true and correct and are incorporated herein by this reference.
- 2. <u>Termination of Easement</u>. The City hereby terminates, releases and relinquishes all easements and other rights created or granted to it by virtue of the 1972 Easement and the 2006 Easement.
- 3. <u>Binding Effect</u>. The covenants contained in this Easement Termination are not personal but shall run with the land and shall be binding upon and inure to the benefit of the fee simple title holder of the Property and its respective heirs, personal representatives, transferees, successors or assigns. The Easement Termination is hereby ratified and confirmed and shall remain in full force and effect.

# **Legal Description of the Private Property**
