

As owner or person(s) responsible for: 237 BATES AVE you are hereby ordered to eliminate all nuisance conditions which are in violation of Chapter 45 of Saint Paul Legislative Code.

1. Deficiency with garage or other structure on the property. REMOVE ILLEGAL STRUCTURE FROM REAR YARD PER NOTICES FROM ST. PAUL CODE ENFORCEMENT, THE ST PAUL SENIOR BUILDING INSPECTOR AND THE ST PAUL BUILDING OFFICIAL. REMOVE ILLEGAL STRUCTURE. Comply before December 8, 2017

If you do not correct the nuisance or file an appeal before December 08, 2017, the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

<u>Charges</u>: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.

APPEALS: You may appeal this order and obtain a hearing before the City Council by completing an appeal application with the City Clerk before the appeal deadline noted above or seven (7) days after the date mailed, which ever comes first. From Emmett Owens on Wednesday, December 6, 2017:

The car port has been up since 2005. The City keeps targeting and I'm not sure if it's because of my color. They had me remove a maintenance-free fence and replace it with a wooden fence, which cost double the price of the maintenance free fence. And there is a white resident a block and a half away with a maintenance-free fence and taller than mine was. I had to spend over \$1,000 painting the wooden fence when they came by with another inspection. I am tired of being harassed by certain individuals who work for the City and I'm paying taxes for the property where the harmless car port is located. A nuisance tree that the City will not take down has smashed two of my vehicles and endangered my property and ripped out my balcony. I'm just their target for some reason. I worked 25 years in a steel mill and they are doing major construction across the street. They are putting a 20 room building over there and there are nails stuck in my tires from the construction outfit across the street. My next step is to try to have a closed door meeting with Chris Coleman. When the new black mayor is in office, I will be bringing attention to him. And they are more than welcome to drive by and look at what I have accomplished in this neighborhood. All I want is to pay my taxes and be left alone. I would like to be a U.S. citizen and shop at Menards and Home Depot and get the Black Friday specials without the City coming by and targeting me. The City is welcome to come by and collect all the bullet cappings and used condoms off my property in this East Saint Paul historic Emmett Jesse Owers M.
