At the end of this hearing, the Legislative Hearing Officer will make a recommendation to the City Council as to whether the license request should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to grant or deny the license.

### **Recommended License Conditions:**

1. Per City of Saint Paul Legislative Code 409.15(a)(2), Wine On-Sale license shall mean a license authorizing the sale of wine not exceeding fourteen (14) percent alcohol by volume, for consumption on the licensed premises only in conjunction with the sale and service of food (menu item only). The sale of Malt On-Sale (Strong) will also take place only in conjunction with the sale and service of food.
2. Per City of Saint Paul Legislative Code 409.15(e), licensee must be able to show that gross receipts are at least sixty (60) percent attributable to the sale of food.
3. Licensee will submit to the Department of Safety and Inspections (DSI) annual gross receipts for food and liquor for each year the license is renewed.
4. No liquor sales and/or service is allowed outdoors without prior written approval and additional licensing from DSI.
5. Licensee agrees to close the establishment by 12:00 a.m. midnight. All patron/customers shall vacate the premises by 12:30 a.m. each day of the week as per City Zoning Code (parking requirements).

**The following requirement must be met prior to the issuance of your licenses:**

- Sign and return one copy of the enclosed license condition affidavit acknowledging the conditions that will be placed on your license(s). A return envelope has been included for your convenience.
- Obtain site plan approval from DSI Zoning Division for the off-street parking, landscaping, the wooden obscuring fence screening the parking lot and the dumpsters from adjacent residential uses. Please contact Karen Zacho at 651-266-9084 if you have any questions.
- Obtain approval from DSI Zoning Division of all business signage on the property (see enclosed sign permit application).
- Provide a Certificate of Compliance Minnesota Workers' Compensation Law.
- Contact Kris Schweinler, DSI Senior License Inspector, at 651-266-9110 to schedule the required in-house review of DSI's Liquor License Manual.
