I do not consider my cherry picker to be commercial equipment. I do not rent, lease or loan the unit to anyone and it never leaves my property, except for repairs.

I'm too old to put up scaffolding and heavy extension ladders for painting and maintenance on my house. My Victorian house is one hundred thirty years old and I love keeping it in good condition. I feel very safe and comfortable when using the cherry picker the last two years, having painted the south and west sides of the house. The house has four floors, not counting the basement, and forty-foot peaks on all four sides.

I park the cherry picker at the rear of my house where it cannot be seen during the winter months. I would appreciate keeping the same spot for parking the unit. Please consider my request.

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **December 04, 2017** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

1. COMMERCIAL EQUIPMENT STORAGE IN YARD.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after **December 13, 2017**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges<sup>2</sup>** and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
