# **CORRECTION NOTICE**

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **August 10, 2017** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

- 1. SCRAPPING/RECYCLING: Scrapping and/or recycling processing is **not permitted** in a residential zoning district per section 66.221 of the St Paul Legislative Code. A home occupation is permitted in a residential district provided it meets the requirements in Section 65.141 of the St Paul legislative code. This section of the code requires and states there shall be no exterior storage of equipment, supplies or commercial vehicles associated with the home occupation. Additionally, it is required that the dwelling unit be the principal residence of one of the persons conducting the home occupation. IMMEDIATELY CEASE SCRAPPING OPERATIONS AND CLEAN UP THE YARD AND DRIVEWAY AS PER THE SUMMARY ABATEMENT ORDER THAT WAS ISSUED ON 8-10-17.
- 2. The exterior walls and/or trim of the house has defective, peeled, flaked, scaled or chalking paint or has unpainted wood surfaces. Scrape and repaint to effect a sound condition in a professional manner.
- 3. The exterior walls of the house are defective. Repair all holes, breaks, missing, loose or rotting siding, to a professional state of maintenance.
- 4. YARD: The yard lacks proper ground cover. Seed, or sod, where needed.

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises for **item #1** on or after **August 23, 2017**, by which date the violations noted must be corrected. The Enforcement Officer will reinspect these premises for **items #2-4** on or after **September 9, 2017**, by which date the violations noted must be corrected **Failure to correct these deficiencies may result in the issuance of criminal charges<sup>2</sup>** and/or a civil lawsuit, and possible
