Re: Order to raze and remove the structure at 106 King Street East

(Council File RLH RR 17-21)

Dear Mr. & Mrs. Morgan:

The Saint Paul City Council adopted an Order to Raze and Remove the nuisance/dangerous building(s) at 106 King Street East in Saint Paul within 180 days on June 7, 2017. The date the work was to be completed, per the Council resolution, is December 7, 2017. The measure of completion of the work and abatement of the nuisance/dangerous condition is the issuance of the Certificate of Code Compliance. In order to make findings for Council consideration of the completeness of the work and need for city abatement of the nuisance/dangerous building(s), as well as the status of the performance deposit, a legislative hearing is being scheduled on **Tuesday**, **January 30, 2018 at 10 a.m. in Room 330 City Hall, 15 West Kellogg Blvd., Saint Paul.**

If you have received your Certificate of Code Compliance by December 7, 2017, this hearing will be cancelled and a resolution will be forwarded to the City Council indicating the nuisance conditions have been abated and the matter is closed.

If you have *not* received your Certificate of Code Compliance by December 7, 2017, you will need to work with Joe Yannarelly (joe.yannarelly@ci.stpaul.mn.us or 651-266-1920) to schedule an inspection to occur *prior to* the week of January 16, 2018. Both Mr. Yannarelly and a building inspector will conduct this inspection.

The findings of the Legislative Hearing will be considered at a City Council Public Hearing on Wednesday, February 7, 2018 at 3:30 p.m. in City Council Chambers, Room 300 City Hall, 15 West Kellogg Blvd., Saint Paul.
