I am appealing items related to the Certificate of Occupancy, Inspector Brian Schmiet Ref No. 112684.

- 1. I was charged twice for missed visits which I was not notified of in writing to my home address which the city has been instructed to use for notification purposes.
- 2. Inspector Schmeit indicated he needs to inspect the gutters again on 2/15/18 because they were frozen at the time of his visit. On 2/15/18, the gutters will likely still be frozen. He would also like to re-inspect the garage threshold on 2/15/18. It has been fixed to code and should already be passed. The letter states I would be charged of this additional visit as well.
