## NOTICE OF INTENT TO SUSPEND LICENSES

## Dear Licensee:

The Department of Safety and Inspections will recommend suspension of the Solid Waste Hauler & Vehicle and Solid Waste Hauler (Each Additional Vehicle) licenses held by GMAN Enterprises, LLC d/b/a Garbage Man St Paul II for the City of Saint Paul. The recommendation is based on the following information:

On February 2, 2018, you were sent a letter and RENEWAL INVOICE from the Department of Safety and Inspections indicating your Solid Waste Hauler & Vehicle and Solid Waste Hauler (Each Additional Vehicle) licenses expired as of January 24, 2018 and you owed delinquent license and late fees.

You were also required to submit the following information along with your license fee payment:

- Current certificates of General and Automobile Liability insurance with a thirty (30) day notice of cancellation
- Current vehicle information with VIN numbers
- Current Schedule of Charges
- Approved Vehicle Inspections (Copy of DOT Inspection Report for currently licensed vehicles and contact DSI Licensing at (651)266-8989 to schedule an inspection appointment for any vehicle(s) new to the Saint Paul fleet)
- A completed Certificate of Compliance Minnesota Workers' Compensation Law form

You were given until February 23, 2018 to pay the delinquent license and late fees and submit the required information listed above. As of today's date neither has been received.

In addition to the suspension of your Solid Waste Hauler & Vehicle and Solid Waste Hauler (Each Additional Vehicle) licenses, per Saint Paul Legislative Code § 310.05 (m) (2), the licensing office will also recommend a \$500.00 matrix penalty for failure to submit required information to maintain your license.

At this time, you have four (4) options to proceed:

- 1. If you do not contest the imposition of the proposed adverse action, you may do nothing. If I have not heard from you by **Monday**, **March 12**, **2018**, I will presume that you have chosen not to contest the proposed adverse action, and the matter will be placed on the next available City Council Agenda for approval of the proposed remedy.
- You can pay the delinquent license and late fees and submit the required information. If this is your choice, you need to contact the Department of Safety and Inspections (651) 266-8989 to determine the total amount now due. You can send the payment and information directly to DSI at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Monday, March 12, 2018. A self-addressed envelope is enclosed for your convenience. Payment of the delinquent license and late fees and submission of the required information will be considered to be a waiver of the hearing to which you are entitled.
- 3. If you wish to admit the facts but contest the penalty, you may have a public hearing before the Saint Paul City Council. You will need to send me a letter with a statement admitting the facts and requesting a public hearing no later than **Monday**, **March 12**, **2018**. The matter will then be scheduled before the City Council to determine whether to suspend your Solid Waste Hauler & Vehicle and Solid Waste Hauler (Each Additional Vehicle) licenses and impose the \$500.00 matrix penalty. You will have an opportunity to appear before the Council and make a statement on your own behalf.
- 4. If you no longer wish to do business in the City of Saint Paul, you will need to complete and return the attached REQUEST TO CANCEL LICENSE with the CITY OF SAINT PAUL to the Department of Safety and Inspections, at 375 Jackson Street, Ste. 220, St. Paul, Minnesota 55101-1806 no later than Monday, March 12, 2018.

If you have not contacted me by Monday, March 12, 2018, I will assume that you do not contest the suspension of your Solid Waste Hauler & Vehicle and Solid Waste Hauler (Each Additional Vehicle) licenses and imposition of a \$500.00 matrix penalty. In that case, the matter will be placed on the next available City Council Agenda for approval of the recommended penalty.
