Thanks for taking the time to speak with me this morning.

The mainline sanitary sewer on Chamber St between Nebraska and Larpenteur:

- Is a 24" diameter sewer.
- Was constructed in 1955.
- Hasn't been replaced, or lined.
- Wasn't replaced with the 2017 street reconstruction project.

There were private sewer services replaced on this street; this is the sewer or pipe from the city mainline sewer to the house. The sewer lining work won't include any work on private sewer services.

The mainline sanitary sewer on Atlantic St between Nebraska and Larpenteur:

- Varies in size from 12" dimeter to 18" diameter.
- Was constructed in 1955.
- Portions have been lined; we won't be re-lining in these stretches.
 - > In 2001, the mainline sewer was lined on Atlantic between Idaho and 1601 Atlantic.
 - In 2014, the mainline sewer was lined on Atlantic between Idaho and 1640 Atlantic.
- Wasn't replaced with the 2017 street reconstruction project.

There were private sewer services replaced on this street; this is the sewer or pipe from the city mainline sewer to the house. The sewer lining work won't include any work on private sewer services.

Lining Project Warranty

There is a 2-year warranty on sewer lining work.

Schedule

I understand your concerns over only receiving a one week in advance notice.

When we receive the Contractor's 3-week Look-Ahead-Schedule for lining in your neighborhood, I will reach out to you. We will work with you and provide as much notice as possible.

Joy Parizek,

I apologize for the inconvenience the lining of sewers in your neighborhood will cause you after you've recently lived through a street reconstruction project.

We won't be digging up the recently reconstructed streets.

Sewer lining work won't require that your windows to be closed. There will be no dust. Noise generation will be limited to the one day of sewer lining.

The sanitary sewers in your neighborhood were inspected before the street reconstruction project. Based on review of the sewer inspection data, we determined that lining could be done successfully without excavation at a later date.

Insituform, the Contractor, has applied for a sound level variance requesting on these streets in your neighborhood:

- Atlantic from Nebraska to Hoyt; installation of the sewer liner is currently scheduled for May 10th.
- Chamber from Hoyt to Larpenteur; installation of the sewer liner hasn't been scheduled yet.
- Nebraska from Atlantic to English; installation of the sewer liner hasn't been scheduled yet.

Insituform will coordinate their efforts with property owners and the City, by providing:

- The City with 3-week Look-Ahead schedule every week.
- Affected property owners with:
 - o A notice of sewer lining work one week in advance.
 - o A notice of sewer lining work one day in advance.

The process of lining a sanitary sewer involves cleaning the sewer and then constructing a sewer liner. Sewer liner construction is done by:

- Inserting resin saturated felt tube made of polyester through existing manholes.
- The resin in the felt tub is cured by a boiler that circulates hot water.
- The sewer liner creates a new long-lasting pipe within the old sewer.
- Connections to private sewer services are restored by the use of a robotic cutter.

We were forced to have windows closed all summer due to the noise and dust.
