Please take notice that this matter has been set on the Public Hearing Agenda for a City Council meeting on **Wednesday, April 18, 2018 at 5:30 p.m.**, in the City Council Chambers, Third Floor, Saint Paul City Hall and Ramsey County Courthouse, 15 West Kellogg Boulevard, St. Paul, MN 55102.

Enclosed are copies of the email you sent on March 26, 2018 indicating that you were not contesting the facts related to the incident, but were requesting the opportunity to address the Council regarding the penalty, the resolution and any supporting documents. This information will be presented to City Council for their consideration.

This is an uncontested matter concerning a complaint-based inspection conducted on February 28, 2018 where an inspector from the Department of Safety and Inspections documented twelve (12) vehicles and a trailer parked on the northern side of the property facing Selby Avenue. Ten (10) vehicles were parked on the southern side of the property for a total of twenty-two (22) vehicles parked on the property where only sixteen (16) vehicles are permitted per license condition #1. In addition, access and egress in and out of the property was obstructed due to the excessive amount of vehicles also in violation of license condition #1.

As a result of this violation, the licensing office will recommend a \$500.00 matrix penalty per Saint Paul Legislative Code § 310.05 (m) (1).
