To CAO for license suspension (business closure)until fine is paid, licensee is in compliance, and awritten approval is received from DSI to reopen after a reinspection indicates that the property is in compliance with all site plan and license conditions. 11/23/2005 License conditions 1-5 (1. Parking for customers and employees shall be arranged on the lot as shown on the approved site plan. No more than 16 vehicles shall be parked outdoors on the lot. The exception to the number of vehicles is the dump truck which will be parked along the south side of the building in the area shown on the site plan. This vehicle shall not be used for the storage of parts or refuse. The dump truck must be operable and used in conjunction with the business.; 2. All vehicles parked outdoors on the lot must be completely assembled with no parts missing. Vehicle salvage is not permitted.; 3. Vehicle parts, partially disassembled vehicles, tires, oil, vehicle hoist or similar items will not be stored outdoors. Trash will be stored in the dumpster in the existing enclosed area.; 4. No repair of vehicles will occur on the exterior of the lot or on the public right-of-way. Vehicles attached to tow trucks shall not be parked in the public right-of-way.; 5. The proposed site improvements shall be completed by September 1, 1998 as detailed on the plan. This shall include fencing, striping for the parking spaces (1 thru 8), landscaping and the removal of the curb-cut on Herschel nearest the intersection of Selby.) have been replaced by order of the City Council and adopted on November 23, 2005 Resolution 05-1090 that Mary Fashing is hereby ordered to pay a fine of \$1,000 within 30 days of passage and approval of this resolution and that the following conditions 1-11: 1. There will be no more than sixteen (16) vehicles parked on the lots (total of front, side and back) at any given time. Vehicles must be parked in an orderly manner, and allow access and egress to other vehicles.; 2. Cars or other vehicles attached to the tow truck(s) shall not be parked on the streets or alleys.; 3 the tow truck will be parked on the lot overnight.; 4. No vehicle on the lot shall be used for the storage of parts, tires, garbage or other items. No vehicles shall remain continuously on the property with the exception of the tow truck.; 5. All vehicles parked outdoors on the lot must be completely assembled with no visible parts missing, and may not be used for vehicle salvage.; 6. No repairs may take place outside of the building on the lot or in the street.; 7. The fence shall be closed during non-business hours.; 8. No vehicle for repair shall be on the lot for more than ten (10) days.; 9. All garbage and refuse must be in the dumpster on the property, and the dumpster shall be kept out of sight to the extent possible and kept in an orderly condition.; 10. Surrounding streets are not to be used for overflow storage of cars waiting to be repaired or waiting for pickup.; 11. there is to be no outside storage of vehicle parts, tires, oil, vehicle hoists or other similar items.
