Utility workers undergo 24 hours of training

About 20 employees underwent extensive Hazardous Waste Operations and Emergency Response for Chlorine and Ammonia training earlier this year.

SPRWS has bulk quantities of Chlorine and Ammonia on site, this requires us to have a Process Safety Management program which includes an Emergency Response Plan for Chlorine and Ammonia. Within that plan, certain operators and employees are required to follow procedures to prevent chemical releases and respond in the unlikely possibility of a chemical release. The HAZWOPER training gave employees more in depth infor-

mation about Chlorine and Ammonia, identifying, reporting, and responding to emergencies as well as table-top discussions considering "what if" scenarios that could possibly result in a chemical release.

All employees are provided Employee Right-to-Know training regarding the hazardous chemicals onsite. If anyone is interested in reading the Emergency Response Plan, it can be found in Documentum in the Process Safety Management Program; Appendix T or contact Hayley Heidelberg for more information.
