## CORRECTION NOTICE

Dear Sir or Madam:

The City of Saint Paul, Department of Safety and Inspections has inspected the above referenced property on **January 16, 2018** and has determined that the following deficiencies exist in violation of the Saint Paul Legislative Code<sup>1</sup> (see footnote 1, below).

- 1. REDIRECT SUMP PUMP HOSE TOWARDS THE MIDDLE OF THE YARD BUT AWAY FROM THE FOUNDATION OF THE HOUSE AND PUBLIC STREET. SUMP PUMP CAN NEVER BE DISCHARGED ONTO THE PUBLIC RIGHT-OF-WAY/STREET/SIDEWALK/ALLEY OR TOWARDS THE FOUNDATION OF THE BUILDING.**

You are hereby notified to correct these deficiencies in accordance with the appropriate codes. The Enforcement Officer will reinspect these premises on or after **January 24, 2018**, by which date the violations noted must be corrected. **Failure to correct these deficiencies may result in the issuance of criminal charges<sup>2</sup>** and/or a civil lawsuit, and possible abatement/assessment by the City. All repairs and new installations must be made in accordance with the appropriate codes. Permits may be obtained by calling 651-266-8989.

You may file an appeal to this notice by contacting the City Clerk at 651-266-8585. Any appeal must be made in writing within 10 days of this notice. (You must submit a copy of this Notice when you appeal, and pay a filing fee.)
