

Wiebesick is a family from Golden Valley, MN.

Wiebesicks rent a portion of their home.

Wiebesicks refused inspection by health inspector.

Wiebesicks received a favorable decision from a 4th judicial district judge. Judge said no administrative search warrant would issue if tenant and landlord refused consent to health inspector to enter home.

Golden Valley appealed and appellate court sided with Golden Valley granting Golden Valley an administrative search warrant based on not probable cause but passage of time.

Wiebesick appealed that decision and Supreme Court of Minnesota picked up the case.

Supreme Court of Minnesota decided on July of 2017 that based on a routine or system of inspection implemented equally that administrative search warrant would be granted in situations where tenant and landlord refuse consent for health inspector to enter home.

Also decided was that an opportunity for all interested parties to attend the hearing must happen. If it is found that interested parties are not given an opportunity to know or participate in hearing that a violation of due process of law would in fact be happening.

Kahn MN court case gives more constitutional protection than the federal constitution when the 4th amendment is involved. Due to the semi colon following the word violated in 4th amendment of Minnesota's constitution. Federal constitution word for word the same has a comma instead of a semi colon after the word violated changing the structure and meaning to afford Minnesotans both protections from unreasonable search and seizures.

i have been trying to relay the decision of Supreme Court of Minnesota decision in Wiebesick to STEVE MAGNER and ED SMITH DSI inspectors who want to serve administrative search warrant 62-cv-17-5738 on 908 Jefferson Avenue for illegal occupation of garage. City of Saint Paul was informed that all interested parties given a chance to come to hearing and participate at hearing in order to enter any remarks that may change the judges mind or to restrict the breadth of the City's intrusion of the home.

908 Jefferson Avenue is not a commercial building or rental dwelling. 908 Jefferson Avenue is a home. Probable cause is needed here. An opportunity for all interested parties to participate is also necessary to meet the due process of law threshold. Ex parte was the type of hearing had for 908 Jefferson Avenue.
