## **MEMORANDUM**

DATE: 5/2/2018

SUBJECT: Summary of the public process and comments received on the proposal for bicycle lanes on Prosperity Avenue, Hazelwood Street, and Prosperity Road.

This memorandum presents a summary of the public process and comments received on Saint Paul and Ramsey County Public Works' proposal to install bicycle lanes on Prosperity Avenue, Hazelwood Street, and Prosperity Road from Maryland Avenue to Larpenteur Avenue. The full text of all written statements received is attached to the end of this memorandum.

Saint Paul and Ramey County Public Works staff began stakeholder outreach along Lexington Parkway in January 2018. A website was created for the project, providing an overview of the planned improvements, data, project documents, visuals, timeline, and a project contact for questions and comments. Each project website was linked to on stpaul.gov/bikeprojects, a website providing a list of all bicycle projects throughout the city.

Notification was sent to the District 2 Community Council (D2), and city staff attended a D2 Board meeting in January to present information on the bicycle facilities proposed. City staff also presented the project to the Transportation Committee of the Planning Commission February. The Transportation Committee recommended approval of the project as proposed.

#### Prosperity / Hazelwood Bikeway Project Meeting:

A City and County-sponsored project meeting was held in January 2018 at the Duluth and Case Recreation Center. Residents and property owners within 200 feet of the proposed project were sent notifications of the open house via mail, along with an overview of the project details and impacts. 393 flyers were sent out for the meeting. The flyers provided a map of the project, a link to the project website, contact information for City and County staff, and information about the project design.

#### **Written Statements Received:**

As of April 27, 2018, city staff received a total of 19 statements specific to proposed bicycle facilities on Prosperity Avenue, Hazelwood Street, and Prosperity Road from the following sources:

- Comment forms from the two project meetings (12 statements)
- Comments sent or forwarded to city staff via email (7 statements)

It should be noted that the total number of statements received may include multiple statements from some individuals, as well as some duplicate statements (e.g. an individual may have provided written feedback at an Open House and provided feedback via email).

## **Major Themes:**

All statements received were reviewed by project staff. Major themes identified in the feedback are summarized below:

- The proposed bike facilities will improve safety, help calm motorized traffic, or improve connectivity (12 comments)
- Concern about the proposed parking removal along the corridor (6 comments)
- Motorized traffic/street conditions along the corridor too dangerous for proposed bike facilities (4 comments)
- Concern about how bike facilities are funded (3 comments)

Thank you for allowing us to weigh in on the issue. At the January Board Meeting, the District 2 Community Council Board of Directors met to discuss the Proposed Bike Lanes. Staff flyered Prosperity in Spanish and English and invited residents to attend and voice concerns however, no one attended the meeting on that issue. Staff attended the meeting at Duluth/Case Recreation Center and heard several concerns from neighbors.

Overall, the board has a history of being supportive of bike lanes and the City Bike Plan although concerns of reduced parking were voiced on this specific project. In the end the board voted to support the proposed Prosperity Avenue/Hazelwood Street/Prosperity Road Bikeway Project as outlined in the City of St. Paul Bicycle Plan. 

This is in regards to the proposal to install bike lanes on Prosperity Road. I live at 1665 Prosperity Road, in the block between Idaho and Larpenteur. I have lived here 25 years. I strenuously object to the installation of the proposed bike lanes on this block. First, parking is already a problem on this block. I am attaching 2 photos I took last Sunday which depict the east side of the road on that block. There are no alleys behind the houses on either side of Prosperity Road, so all parking is either driveway or street. Second, the lanes would create a serious safety issue. There is a sidewalk on both sides available for bikes. The proposed bike lanes would force riders to be next to busy traffic lanes, with cars entering the road from driveways and street parking. Prosperity Road is already too busy as the preferred alternative to White Bear Avenue, and the speed limit is largely ignored here. Finally, I have not noticed a great deal of bike traffic on this street. The state trail is only a couple of blocks north, and it is much safer for cyclists. Resurface the road, but leave the traffic and parking lanes as they are now. Gary Davis

Good afternoon Mr. Hanson,

I will be unable to attend the public hearing on May 2<sup>nd</sup> but, I do wish to state that I oppose this planning. Prosperity is the main thoroughfare that we use to commute to work each day, reach our local businesses, walk our dog, just about everything. The area where the bike lanes are proposed to be is also an area with a lot of traffic. Just the school bus traffic alone sometimes causes problems but bike lanes added to it would be even worse.

Due to how busy that street is, I also wonder about the safety of any riders utilizing bike lanes. It seems like there is more and more traffic and traveling at higher speeds than should be. The stretch between Maryland and Arlington is very heavily traveled. Disrupting traffic flow would require people to travel at posted speed limits but; it may also impede the safety of people utilizing the bike lanes.

In closing, I would like to add that it's very rare that I see people utilizing the bike lanes we already have in our community (Johnson Pkwy for example), and I wonder how the cost of constructing these is balanced with the underutilization. I also believe that under-utilization in some of these areas could be directly related to the traffic volume. It seems to me that we could be utilizing community funds/taxpayer monies in better ways. Thank you.

Re: Bike Path Project, Prosperity/Hazelwood

In regards to the above referenced matter I am writing this letter for I will not be able to attend the meeting on January 23, 2018.

As a home owner and life long resident of St. Paul, I feel that this Bike Path Project is an unnecessary and an inconvenience to all home owners.

Going by this plan there will no longer be parking on both sides of the street. That alone is going to cause a ray of problems and headaches for all homeowners. At the times that your survey was done, it did not show the actual number of vehicles that park on these streets on a daily bases. Nor did your survey take into account if there is a snow emergency on the east and west streets, all those cars then park on the north and south streets. Another inconvenience to any and all homeowners that was not taken into account is if anyone should have quest at their homes – where are their quest supposed to park.

Hazelwood Street has an over abundance of traffic, the MTC stopping about every other corner, school buses, vehicles using Hazelwood instead of White Bear Avenue (which started when White Bear Avenue was being worked on), school buses lined up on one side to drop off and pick up children and garbage trucks picking up trash, and in the winter months if the streets are not plowed curb to curb (which does happen often), You want to make the street even narrower all for what. A bike path, Serious. You are allotting 7' on both sides of the roadway for a bike path, and 11' for

a vehicle on both sides. How is this justified. All vehicles pay for the use of the roadways, via vehicle insurance, vehicle registration tabs and of course homeowners paying their property tax, and now you want to make our roadway narrower so a bicycle that at its widest point is 1 foot can have a 7' lane of their own. Where is the justification in that?

I am also wondering when you were measuring the street to justify parking on one side did you take into account that by law you have to stay 5' from a driveway, which if you do not you can get ticketed and towed. So by leaving 5' from each driveway you are losing 10' from driveway to driveway. You also need to leave 5' from the alley ways when parking – was that taken into consideration as well.

Also, by making all the cars park on one side, you are putting the lives of people of all ages in jeopardy for now they will be forced to try and cross the street. Regardless of the fact that some people seem to think that all vehicles will stop for pedestrian or the fact that they think vehicles can stop on a dime – that is not true. And again, for what - a Bike Path.

Also in your survey, did you happened to count the number of bicycles that were in this area? After checking my surveillance cameras, (which took hours), there was one person on a bike on a daily basis. Also, in your survey did you check out all the bike/walking paths there are in this area? All of the unused railroad tracks where turned into bike/walk paths which are used on a daily basis instead of the street. So why would we need a bike path – we don't.

People who purchase their homes in St. Paul do so for many reason, one being that we are able to park on both sides of the street, which believe it or not is a important factor, for if it wasn't we could have bought homes in Hennepin County (MPLS) – which we did not.

If this bike path project goes through, we the residence of St. Paul/Ramsey County feel that it will be a waste of money. The money that is paid to all the employees that are involved in this, from the office people to the workers. Said money could be spent in a much better and more needed way.

I know if the city decides to do something we as homeowners are asked for our input, but at the end of the day, our input does not matter. This project is no different. As for your meeting to voice our opinion, I cannot believe the area you pick to hold it. The Duluth & Case Rec Center at 6 o'clock at night, a place where the St. Paul Police will tell you that it is not a safe area to be in. If you are lucky enough to get inside the rec center, hopefully your vehicle will still be there when you walk out. All of the residence I spoke with will not attend the meeting for that reason. Is a low attendance count what you where looking for, so less people can appose said project?

Also, if said Bike Path Project goes through against the homeowners wishes, will said Bike Path be monitored each and every year to see that it is not being used like you had hoped and then removed?

Again, as a residence of St. Paul/Ramsey County I am against the Bike Path Project, it is an unjustifiable project and an unjustifiable use of funds.

As I talked to both of you last week, Kathy asked me to send an email in regards to the information we discussed.

I am concerned that there is a proposal for a bikeway when we already have a bike trail only four blocks to the south. It already runs north to south. It is were the old railroad tracks were and connects from downtown St Paul all the way to Forest Lake.

I have lived here for over 40 years. The amount of bike traffic we have is very small. During the winter, one or two bikes max a week if that. During the summer approximately 4 or 5 a week. That is being generous.

My concerns include: losing residential parking, safety, and the location of the meeting.

**Losing residential parking**: I was told there have been 15 times someone has come out to figure out there will still be enough parking. I believe that this needs to be addressed more as there are many that use both sides of the street from 4pm-9am Monday thru Friday. Also, there are a lot more people who use it on Friday thru Sunday. During the weekdays, there is a lot less usage during working hours as people are gone to work.

During the winter-this is a snow emergency route. Even tho we are plowed, most of the winter it is not curb to curb. Just this last week we have lost about a foot on each side. Also, when east/west streets are plowed our street is full on both sides. They all parked down here so they will not get towed.

The map you enclosed (I had to take out a magnifying glass to read the dimensions) shows there will be 7' for the car/trucks to park. And each bike lane is allowed 5' and 6'. I am not sure why a bike needs this amount of room. Also the map shows, NB and SB for bike lanes. I assume the SB would be on the west side of the street (even) and the NB is the east side of the street (odd).

Down by the French Immersion school, the buses already park on the SB lane (westside). The parents park on the NB lane (eastside) to drop off their students and pick them up.

**Safety:** This will not be a bike friendly path for families. This puts the children between moving cars, trucks, and buses and stationary parked cars.

The vehicle traffic on this street has taken an upward climb ever since White Bear Ave was worked on in the last couple years. Vehicles were detoured to Hazelwood during this time. After the construction was over, people continued to use it as an easier way to get downtown. This street also has a lot of MTC buses and school buses.

**Location of Meeting:** The location and time for the meeting is not very favorable for having people come for input. I have been told by many that crime in that location is up especially after dark.

**If this proposal does go thru**, I hope there will be a time designated after a year to see what the bike usage is. If it does not increase considerably, I hope that the bikeway would be taken out and parking restored to the neighborhood.

As I told you, I will be unable to attend the meeting as I just had total hip replacement. Please let me know what the outcome of the meeting is and what the next steps will entail.

Thanks for listening to my concerns.

Thank you for your message concerning the proposal for bike lanes on Prosperity/Hazelwood. Your message has been received, and will be added to the public record for this project.

Specific to your comments, we're hosting a meeting specifically to receive feedback from residents along the corridor and provide an opportunity to discuss the proposal with city and county staff. The proposal itself comes out of our city bike plan (a four year planning effort) that was adopted by our City Council in 2015. The objective of this proposal is to make it safer and more comfortable for people to bike on the street, while also discouraging speeding through the neighborhood. There will also be a city council public hearing for this project, where the council will vote on whether bike lanes will be included with the street resurfacing. While the date of the hearing has not yet been finalized, you will receive additional notification in the mail when the date has been set.

Related to parking near your home, do you have driveway access to your property? Since I am uncertain exactly where your property is located, I can't speak specifically to where your guests would park, but I'd be happy to discuss with you if you'd like to call or send another message. For your review, I have attached the parking report that staff prepared for this project to this email. All of these parking counts were performed by city and county staff, and I can confirm that the counts were performed on Prosperity Ave, Hazelwood St, and Prosperity Rd.

## Maryland to Larpenteur

There is currently parking on both sides of Prosperity Avenue, Hazelwood Street, and Prosperity Road. To add bike lanes, parking would need to be removed on one side of the road between Maryland and Larpenteur avenues.

Parking counts were performed on Prosperity Avenue, Hazelwood Street, and Prosperity Road. The amount of parking spaces will be reduced after installing bike lanes, but should meet the current parking need.




