The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 4:00 p.m. to 8:30 p.m., with a pre-event sound check at 3:00 p.m., for the Twin Cities Burger Battle on Saturday, May 19, 2018. 2) All electronically powered equipment used in conjunction with the event shall not exceed 95 dBA as measured 50 feet from any sound source. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. The applicant may need to provide a barrier, to act as a sound absorber, to contain excess sound from leaving the area 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:30 p.m. on the date of the event.
