The items on the list must be corrected prior to the re-inspection date. A re-inspection will be made on April 12, 2018 at 2:00 P.M..

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

### DEFICIENCY LIST

1. Bathroom upstairs - SPLC 34.11 (1), MSBC 2902.1, SPLC 34.35 (1), MPC 301.1 - Repair or replace and maintain all parts of the plumbing system to an operational condition.-Repair or replace and maintain an approved private toilet. This work may require a permit(s). Call LIEP at (651) 266-9090. Secure toilet to floor.
2. Bedroom south east side - MSFC 1030.1 - Provide and maintain an approved escape window from each sleeping room or area, or discontinue use of area as a sleeping room.

This work may require permit(s). Call DSI at (651) 266-8989.-Remove storage fans tables from one of the windows so it can be used for emergency escape.

3. Kitchen - SPLC 34.10 (7), 34.17(5) - Repair and maintain the floor in an approved manner. -Repair or replace the floor tile.
4. Rear exit door. - SPLC 34.09 (4) i - Repair and maintain an approved one-inch throw single cylinder deadbolt lock. -
5. SPLC 34.09 (4), 34.33 (3) -Provide or repair and maintain the window screens-
6. SPLC 34.14 (3), MPC 4714.01 (T) - Provide and maintain an approved ventilation system in all bathrooms. -Provide a cover for the bathroom fan.
7. MSFC 1014.2 3. Means of egress from dwelling units or sleeping areas shall not lead through other sleeping areas, toilet rooms or bathrooms. -The bedrooms upstairs from the west side goes through the bedroom on the east side one of these rooms cannot be used for sleeping rooms.
