Multiple times a week, I walk or drive on Wheeler to get to the YMCA, Dickerman Park, the Green Line, and many other amenities in the Hamline-Midway. Each time, I feel that I'm taking my life in my hands when walking in the street as cars, trucks, and sometimes buses buzz through to get to University, Thomas, Fairview, or Minnehaha. When driving on Wheeler, I fear that I'll fail to see a pedestrian trying to dodge moving vehicles on the street and in parking spaces.
