

## Utility posts business division manager and water treatment plant operator II positions online

The water utility is seeking to fill the position of business division manager and water treatment plant operator II.

The **business division manager position** is an internal posting that closes May 21. This person will oversee the finance, IS, meter operations, and call center sections.

Must have a bachelor's degree from one of the areas listed on the posting (can be from one of several disciplines).

Must have eight years of employee development, project management, planning or budget experience. Must have four years of supervisory experience. No substitution for supervisory experience, but can use master's degree as substitute for other experience.

The **water treatment plant operator II** position closes on May 22. This person is responsible for the functional operation of the water softening and purification equipment at the plant. Operates filter units, controls the flow of water into and through the treatment process. Monitors and controls the application of all of the chemicals used in the treatment process. Performs chemical tests and monitors the results. Monitors performance of plant machinery and makes minor maintenance and emergency repairs.

Must complete one of the following:

- A post-secondary program in water or waste water treatment.
- Two years of post secondary education with an emphasis in math or chemistry.
