The City Council will have the final authority to grant or deny the license.

If no objections are received, your license will be issued (pending any requirements not completely met) approximately one week past the date given above.

If objections are received a hearing will be scheduled before a legislative hearing officer. You will receive notice of the time, place and date of the scheduled hearing from the Legislative Hearing Officer. At that hearing, the hearing officer will take testimony from all interested persons and will make a recommendation to the City Council as to whether the license(s) should be approved or be referred to an administrative law judge for further review. The City Council will have the final authority to grant or deny this license application.

**Requirements including the following must be met prior to the issuance of your licenses:**

- Sign and return one copy of the enclosed license condition affidavit acknowledging the conditions that will be placed on your license(s). A return envelope has been included for your convenience.
- Submit a copy of a signed lease. **NOTE:** if your use of the property is not specified within the lease, a separate letter signed by the property owner (or designated representative) allowing this type of use must be submitted.
- Obtain all necessary building and/or trade permits related to any construction work associated with the establishment of this use, and all required inspection approval(s) related to these permit(s). Only licensed trade contractors authorized to perform work in that trade (e.g., plumbing, electrical, ventilation, etc.) may obtain permit(s) and/or perform work in such trade.
- Obtain DSI Environmental Health Inspection approval from Barb McMonigal-St. Dennis, DSI Environmental Health Inspector by completing actions including the following:
  - Submit plans and information as previously described to you by Ms. McMonigal-St. Dennis demonstrating how you will comply with applicable City regulations as found under Chapter 427 of the City of St. Paul Legislative Code (see enclosed copy). For further clarification on the information that must be included with the plans you or your designer may contact Ms. McMonigal-St. Dennis directly at 651-266-9137 or via email at [barb.mcmonigal-st.dennis@ci.stpaul.mn.us](mailto:barb.mcmonigal-st.dennis@ci.stpaul.mn.us)
  - After plans have been approved, you may begin construction and then contact Ms. McMonigal-St. Dennis to arrange for site inspection approval.
