Hello,

I am writing to state that I am opposed to Stone Saloon/Waldmann Saloon at 445 Smith Ave. North being granted a liquor-outdoor service area license, licenses no. 20170000652.

I am against the outdoor service, this establishment is located in a residential neighborhood surrounded with family homes on both sides of the building, across the street and behind. The noise level of people talking, laughing and dishes clanking will be heard in my home when I am trying to relax (I live 1 house away). The noise level of people coming and going is already annoying, not to mention not being able to find a parking spot or leave my home on the weekends in fear of having to park a mile away with groceries or other items I need to carry.

I am also questing the signatures of surrounding residents that Mr. Schroeder states that he has received. I attended the Heritage Preservation Commision Public Hearing Notice File No. 18-017 on Thursday March 8. One thing that really stood out to me was Mr. Tom Schroder stated he received 58 signatures in favor of the patio within the 300 feet of the Saloon needed to be approved by the City. Only 28 homes in the 300 foot radius of the 445 Smith are homeowners, all other properties are rentals and a couple Airbnbs. If possible I would like to get a copy of said signatures. I have also attached 47 pages of documentation of residents who own and live in their homes and who is renting out their home to tenants that come and go. I have also included a map of the 300 foot radius along with a map highlighting the residents living on the east side of Smith Ave. have parking permits and restricted parking and which sections right off the highbridge you will no longer be able to park at once the bridge is reopened. Again I would like to see the signatures.

Mr. Schroder has also submitted letters from the Fort Road Federation approving their support of the patio and saloon and that he has obtained the approved signatures. Mr. Schroder is related to the Yust family who is part of the Fort Road Federation and Mr. Schroders architect. The Yust's own 2 homes and Mr. Schroder owns a home in the 300 foot radius, both parties have parking permits, so parking is not an issue for them, nor is the noise level as they are near the edge of the 300 foot radius.

As a 28 year long home owner at 463 Smith Ave. North, I am against the outdoor service area. The noise level will be unbearable, I will hear people laughing, talking and noise of dishes while relaxing or sleeping. Also due to the amount of increased foot and parking traffic that will be in front of my home, again I live 1 house away. The residential homes in this area do not have large front lawns, our homes on average are 10 feet from the sidewalk.

I am also inviting you to come to my home if you would like to observer the current parking problem and foot traffic noise level of people who are giddy from having a good time, nothing against a good time, eating and drinking, I enjoy doing all 3 myself.


