leaving) There was a large group leaving the bar, it started as a verbal argument and quickly escalated into a physical confrontation. We called the police and several squads arrived within minutes. They used some kind of spray (mace?) to subdue people. The fighting has got to stop out here. The bar owners/ management need to do a better job at making sure their patrons are not disturbing neighbors. This has been going on for many years now and something needs to be done about it. This is not only a noise disturbance- This is a public safety issue. Also, they need to clean up the trash in the lot and alley more frequently and do a better job at making sure people do not leave with plastic cocktail cups and beer bottles and litter them in the alley. Finally, the patrons of this bar need to be told that the alley and the back of the Klub Haus and neighbors back yards are not the restroom The dumpster is overflowing and garbage is strewn down alley--The patrons of this bar leave a mess and the bar owners/management are not proactive about cleaning up after them. Often I find plastic cups and beer cans in the alley behind this establishment. They are not allowed to be drinking in the patio area- but people are sneaking beverages out into the lot and alley area. I am also concerned about the loitering and sometimes the fighting that goes on in the parking lot area and alley (especially on weekends). Now that the weather is getting warmer I have already noticed an increase in this behavior. Several bags of trash dumped in the alley Owner Rice Properties Llc - Trash in parking lot Broken glass, beer bottles, litter and trash in this parking lot. Patrons go out to the patio with drinks and stray into the parking lot where fights break out and bottles are thrown to the ground.

The managers don't seem to care what takes place outside the bldg. Police are called, it quiets down, then starts up again. Patrons are carrying drinks across the alley to private residence.
